WITNESS STATEMENT (	HIA 49

HIA 49 will say as follows:-

#### Personal details

1. I was born of the in the sisters and the brother. My mother left us and our father took us to Northern Ireland. My father could only get accommodation in a hostel and they could not accommodate four children. My eldest siste NHB 14 was taken to Nazareth House in Belfast. My brothe SND 157 was sent to Termonbacca and my sister SND 102 and I were sent to Nazareth House in Derry.

#### Nazareth House, Derry (1/6/1964 - 1969 approximately)

- 2. I was placed in Nazareth House on 1<sup>st</sup> June 1964 when I was great years old. I stayed there until I was around great years old. When I arrived at the Nazareth House I remember screaming because I had never seen a nun before. I was terrified. When I arrived they stripped and bathed me and put on different clothes. I had long hair and they cut my hair short right round my ears. All the other girl's hair was cut short in the same way.
- Every morning we got up around 7.30am and went to Mass and then had breakfast. After breakfast I had to carry out my duties at around 8.30. Then I went to class which was on the premises. We had teachers who were nuns and outsiders.

- 4. My duty was to clean the toilets near the chapel. This was my duty the whole time I was in Nazareth House. I think there were four or five toilets. I had to carry a metal bucket full of scalding hot water, a cloth and scrubbing brush. I had to scrub the tiles on the walls. On many occasions when a toilet was blocked and I was in class, I was sent for. If a toilet was blocked I had to put my bare hand down the toilet and carry the excrement with my hands into the next toilet in order to clear the toilet. Sometimes SR 59 o SR 9 stood over me shouting at me to hurry up when I was cleaning the floor. I cried a lot and felt sick and dirty. SR 9 is now dead. SR 59 went to Dublin for training and she now lives in
- 5. When the toilets were cleaned to SR 9 's satisfaction she then gave me a big bucket of scalding hot water with Jeyes Fluid in it to wash the floor. I had to get on my knees and clean the floor with a big floor cloth.
- 6. SR 59 always sent me back to clean the toilets for badness. I knew I had cleaned the toilets well and that I had finished them all properly.
- 7. One day SR 9 was in a bad temper. She came in to the toilet and there was still excrement on some of the white tiles on the walls. She made me use my nails to scrape the excrement off the tiles.
- 8. SR 9 had a white metal bucket with a metal and wood handle. One day she emptied boiling water from the bucket onto the floor where I was kneeing. I was scalded. She smacked me round the face because I was screaming. I was 8 years old. I didn't receive medical attention bu SR 9 threw a bucket of cold water over me.
- 9. I didn't see my sister SND 102 because we were put in a different group. I was in SR 52 's group. We have no bond today as a result.

- 11. I got teased because I spoke with a accent. I was made to feel different.
- 12. I started wetting the bed in Nazareth House. It was a different life. I was used to a family life.
- 13. In the morning the nun would pull your blanket back and she would check if your bed was wet. If you did wet the bed the nuns and other girls called us 'the wet the beds'. I wore a bri-nylon nightdress with long sleeves, sort of mid length. It was always stuck to me because I was soaking wet after wetting the bed. We would also be made to put the wet pants or sheet over our heads.
- 14. If we wet the bed we had to strip our beds and put the sheets in the bath for staff to wash.
- 15. When we got up we were only allowed to wash our face. We never got toothpaste. Only the seniors had toothpaste. I always remember the white soap said ER on it.
- 16. Those of us who wet the bed were made to stand at breakfast time and did not get any tea as punishment. Other girls at the table laughed at us.
- 17. After school we had tea. The rules were that the 'wet the beds' were not allowed anything to drink, only their meal. After tea it was homework and choir practice some nights. We never got any assistance with our homework.

- 18 SR 59 used to say to me sometimes 'oh so you were out on your boat last night'. She was referring to me wetting the bed, but as a child I never knew she was being sarcastic.
- 19 SR 59 used to say the reason I slept beside the door in the dorm was because I was smelly and no one wanted to sleep beside me.
- 20. We had to go to confessions on a Saturday afternoon. The chapel was in Nazareth House. One day I was in the confession box. I was really scared. The priest called me HIA 49. I wondered how he knew my name. He was nice to me. He then brought me into his confession box which had a gold velvet curtain. He sat me on his knee and then he put his hand down the front of my pants. We didn't wear like little girls panties. They were bloomers and the nuns patched them with sheets. I was 8 years old.
- 21. The following week no matter if I was in the middle of the queue or the front of the queue for confessions SR 59 always took me by the hand and put me to the end of the queue.
- 22. I think SR 59 knew what she was doing because she always handed me over. She put my hand into the priest's hand. She knew exactly what was going on.
- 23. I remember clearly what the priest looked like. He had dark thick eyebrows and he was tanned. While I cannot be certain of his name I believe his name was SND 61.
- 24. He used to take me into the sacristy behind the altar. In the room there was a big wardrobe with lots of different coloured vestments hanging up. He locked the door. I was frightened.

- 25. He made me sit over at the door on the floor and take my pants off. I had to sit with my legs open. He sat on a large chair and started masturbating. In those days I didn't know what he was doing.
- 26. Then the regular thing was that he made me kneel in between his knees and he was making me put my mouth round his private parts and masturbate him. He was very rough with me and he was pulling my hair. I was crying. I was so scared of him.
- 27. On many occasions the priest put his finger inside the front of my vagina. He made me perform oral sex on him. He had anal sex with me. He told me I didn't have to do any penance because God was happy with me.
- 28. Every Saturday those that wet the bed were put in the first bath. The bath contained Jeyes Fluid and it was very stingy if I was abused that same day. The pain was terrible and I used to scream. The nuns or seniors who were washing us hit me with a wooden scrubbing brush to make me stop. I can still feel the pain sometimes when I have a bath.
- 29. After he was finished abusing me he would send me back to my group. Sometimes he gave me a mint.
- 30. This went on from when I was 8 until I was 12 every Saturday. This abuse stopped when I was 12 only because I started at St Cecilia's High School.
- 31. I dreaded Saturdays coming. As a result of the abuse I felt dirty and horrible.
- 32. The abuse became a way of life. I knew what was going to happen on Saturday. It was just normal. I didn't like it happening and I didn't want it to happen. I had no friends in Nazareth House. I didn't know why I was being punished in this way and I never reported it.

- 33. Then I would still have to meet that priest on a Sunday at Mass in the chapel. I would have to go up to him and get Holy Communion. I felt that he would sort of look at me and snigger as if we had a secret and I couldn't tell anybody.
- 34. I plucked my eyebrows until I had none. I didn't want to have eyebrows like that priest. I hated hair all my life because of always seeing his pubic hair. I used to spend hours and hours pulling my hairs even out of my face and everywhere. This was mental torture as a result of the sexual abuse by the priest.
- 35. I also recall a priest known to me a SND 106 and; I think his first name was SND 106. He used to bounce me up and down on his knee. As he did this he would have an erection and would rub up against me. I remember him doing this to many children other than me.
- 36 SR 59 bullied me and picked on me. She treated me differently from the other girls. She told me I was a demon, the devil's child. I never received any positive comments.
- 37. In summertime when we were outside on the grass SR 59 had her favourites surrounding her. One of her favourites was SND 160. She used to get them to say things to me like 'no wonder your father didn't want you he couldn't be bothered washing your wet bed'. These comments were hurtful because I knew my daddy loved me. SR 59 made me sit with my back to her and I was getting sunburned but she didn't care. I believ SND 160 went to Sligo with SR 59.
- 38. On many occasions SR 59 would not allow me to go to the toilet despite several requests. Then I got my legs beaten for wetting myself. I remember one day I was sitting on the grass outside and I had to pee myself because she wouldn't let me go to the toilet.
- 39 SR 59 would never let me play. In the hall she always made me stand with my nose in the corner. She said to her favourites that 'one of these nights the

devil will come and take her away'. Every night after I was frightened the devil would come. She took away all my childhood.

- 40 SR 59 used her knuckle to hit me. She hit me on the head and spine. It was very painful. Then the seniors started to do the same on the juniors.
- 41. On one occasion I watched SR 59 pull my sister SND 102 by the hair and kick her. This was normal for SR 59.
- 42 SR 59 was usually on duty for bath nights on a Saturday night. All those who wet the beds got in the first bath. We all lined up and used the same water. There was Jeyes Fluid in the water. The bath smelled the same as the toilets.
- 43. One senior would wash us and another one dried us. I still have a problem today with baths because they used a wooden scrubbing brush. It was like something you would scrub the floor with. It used to sting me so badly and I used to scream. The more you screamed the more you got hit.
- 44. The senior girls hit me with the wooden scrubbing brush on the elbow, shoulders, back and head. It was painful. The worst pain was wher SR 59 smacked me on the face, backside or legs. It left red hand prints.
- 45. During the summer we used to bring two big iron tubs on two wooden benches and one was to wash and one was to rinse. The water was scalding and there was head lice in it. The seniors held my head under the water.
- 46. We were given what I would describe as pork fat or belly. I would describe it as a fatty jelly. I couldn't eat it and I used to throw it under someone else's table. We were desperate to get rid of it. I wore a pinny and sometimes I used to put the meat in my pocket.

- 47. One day SR 59 came over and I still hadn't finished the meat. Then she held my nose and force fed me. She grabbed my throat to make sure that I swallowed it.
- 48. A few times I was sick on the floor. Once she got a big table spoon to pick up the vomit and succeeded in making me eat it.
- 49. I have suffered from bulimia all my life because SR 59 kept saying to me that I had a mortal sin in my soul. I didn't know what a mortal sin was. I thought it was a big black spot inside my stomach and it was getting bigger. So I thought if I didn't eat food it won't grow inside me. It started when I was 10 years old.
- SR 59 used to come round at 11pm at night and she woke up 'the wet the beds' to go to the toilet. On one occasion I had already wet the bed and she grabbed me out of the bed and made me strip my bed. She then raced me down to the bathroom to put the sheets in the bath. She smacked my face and used her knuckles on my back and head. She grabbed me by the scruff of the neck and took me out to the back stairs. She told me to stand there and she turned the lights off. I had to stay there all night. I was in my bare feet and I must have fallen asleep. I always remember it was a winter night because the wind was howling.
- 51. I woke up in the morning to SR 59 beating my legs and shouting. She made me get washed and dressed and then go down to chapel.
- 52. SR 59 always shouted things at me like 'it's because your father doesn't want you'. She made me feel I was the reason my mother and father broke up and I carried that guilt with me through life.
- 53. I didn't get any pocket money or sweets. SR 52 said it was because I wet the bed.

- 54. Sometimes my father used to come on a Saturday and take SND 102 and I out. He had nowhere to take us as he was living in a men's hostel so we used to sit in a field and he used to buy us McKeowns toffee bars.
- 55. On a Sunday afternoon there was a film in a classroom on a big screen. If I wet the bed I was made to stand in the corridor until the film was over.
- 56. At Christmas we put on a concert for the Bishop. He gave out presents and I always wished for a dolly but I always seemed to receive bath cubes, which I felt was a reference to my bed wetting.
- 57. During the summer holidays we were sent to families. One year I was sent to to a lovely family called the SND 161. The first time I went I was about 9 years old. I really liked being out on the farm. I loved it. I could have lived the rest of my life there because I wasn't getting touched or abused.
- 58. If we had any problems with our teeth we were sent to Riverview Park near Nazareth House where the welfare office was. It wasn't a dentist's surgery. They pulled out my teeth even though they could be filled. I have false teeth now and I blame them for this.
- 59. One nigh SND 103 hac SND 105 over sitting in the chair beside her bed. They were whispering to each other. These girls were older than me and maybe about 14/15 years old. They called me over and pulled my hand and made me touch so vagina. They kissed and threatened me to do it too. Eventually they allowed me to go back to bed. This happened over a period of about 3 months and I never reported it as no one would have believed me.
- 60. The older girls getting the younger ones to touch them was normal. They blackmailed me by threatening that they would tel SR 59 that it was all my fault.

- 62. Nobody told any of the girls about their body growing up and about sexual development. I didn't know about periods or puberty.
- 63. In Nazareth House I was sexually, physically and emotionally abused, neglected and bullied.
- 64. One day I was taken by the Social Worker Miss Black in a Volkswagen to Dhu Varren children's home.

#### **Dhu Varren, Portrush (1969 – 1970)**

- 65. I went to Dhu Varren on the 7<sup>th</sup> November 1969 when I was years old. It was like one big family. It was great. I went to High School in Coleraine and I loved it. If you were late in you were taken up the back of the stage and you would get six of the best with a cane. I only got it once and it taught me never to be late.
- 66. The home trusted me to get the bus and go into Coleraine to my school and to come back home again.
- worked as a carer in the home and she lived in Ballymena. She used to give me vodka and cigarettes. I was about years old. She went on a date to the beach and brought me along. She used to make me sit and turn my head and look at the water while she had sex with her date.
- was in charge. There was a nurse and she was from Belfast. They were lovely people. They didn't know XY3 was giving me vodka. I was very well fed in Dhu Varren.

- 69. I befriended a boy called XY 5. I told XY 5 about things that happened in Nazareth House. XY 5 and I were touching each other. I was showing him what the Priest was making me do.
- 70. One night I ran away from the home to go back to Derry because I thought I told XY 5 too much. I spent the night in a caravan with students who were good to me. The following day I got a lift back to Derry with a man called SND 104. He was staying in a nearby caravan on Dhu Varren caravan site. I was about 14 years old.
- 71. One day SND 104 pulled up outside my school. He took me and my friends SND 107 an SND 163 for a run in his car. He sent them to get chips but he took me away and then he abused me.
- 72. Other times he collected me at school and took me to the reservoir and he was touching me and making me touch him. He started taking down his trousers and moving my seat and I got up and I ran out of the car and I kept running towards the reservoir and he kept calling me back. He grabbed me and he took me home.
- 73. On 26<sup>th</sup> July 1970 I ran away to my sister's house in Derry. I returned to Dhu Varren briefly but was placed with my sister on the 7<sup>th</sup> August 1970. Social workers came and took me to the Sisters of Mercy in Newry on the 20<sup>th</sup> January 1971.

#### Sisters of Mercy Home, Newry (20/1/1971 - 18/3/1971)

- 74. I was taken to the Sisters of Mercy Home in Newry on 20<sup>th</sup> January 1971 when I was fourteen.
- 75 SR 49 was a nice old nun. She made me feel very welcome. There were nice girls in the place. There was kindness.

76. I was there for about three months.

#### St Joseph's Training School, Middletown, County Armagh (6/4/1971 – 5/4/1974)

- 77. I was moved to St Joseph's Training School in Armagh under a Place of Safety Order on the 18<sup>th</sup> March 1971 when I was years old.
- 78. I loved it. I'd never had a hug in my life and I got a hug of SR 67. There was SR 68 and SR 69 who was the head nun. She loved us all. They treated us like human beings and trusted us. The nuns were kind and considerate.
- 79. I was so happy there and the nuns were so lovely. I wished I had lived there the rest of my life. I was so happy because I was safe.
- 80. I left St Joseph's to go and live with my mother in on the 28<sup>th</sup> August 1972. I was officially discharged from St. Joseph's on the 5<sup>th</sup> April 1974.

#### Life after care

- 81. I left care when I was a years old. I married when I was I was married for eighteen months and had a daughter called SND 164. However, I couldn't cope with having a family. I turned to drink and drugs. I have been back and forth to England and have never been able to settle anywhere. I have two sons called SND 165 and SND 166 to another partner.
- 82. I feel I have been punished all my life. I couldn't tell anybody about the abuse. I felt rejected. I felt like everybody hated me and I had nobody that would give me a chance in life. I was destroyed and damaged. I was robbed of my childhood and my life.

- 83. Many friends have died who were also abused SND 167 died last year. SND 168 died as a result of drink and she told me she was sexually abused as a child.
- 84. A nurse came once and gave us a sugar cube vaccine for polio. I didn't get any inoculation injections, not even for BCG because they kept moving me. I was eighteen months here and eighteen months there. I don't think I got half the injections I should have.
- 85. I have tried to commit suicide on several occasions. I have taken overdoses and jumped in the Foyle. I have also self harmed. I have been in psychiatric units in and in the past. I now attend a support worker once every two weeks. My support worker is a nurse from a Mental Health Team in I go out shopping with her and for a chat. I have told her about the abuse I have suffered.
- 86. I saw a Spotlight documentary about abuse 3 or 4 years ago. Following this I attended a victims and survivors meeting in the City Hotel in Derry. This encouraged me to make a statement to the police around this time. I have been dealing with Constable Vincent Gillan in Maydown Station. My solicitor is KRW Law in Belfast.

١,	HIA 49 will say as follows:-
1.	This is an addendum to my witness statement dated 19 <sup>th</sup> September 2013.
2.	I have been advised by the Inquiry into Historical Institutional Abuse that the legal representatives of Father SND 106 have stated that I have misidentified him. I am told that the legal representatives have suggested that a Father SND 407 was the Chaplain at Nazareth House, Bishop Street, Derry during a large portion of the relevant time that I was a resident there. I am also informed that the legal representatives have suggested that the nickname of that priest was SND 407
3.	The Inquiry has asked me if I recall Father SND 407 or SND 407 SND 407, whether as a former Chaplain in Nazareth House or a visitor. I do not recall a priest called Father SND 407 or SND 407  That is not to say there wasn't such a priest. However I do not recall the names of any of the Chaplains or visiting priests during my time in Nazareth House other than Father SND 106 and Father SND 61 whom I name in paragraph 23 of my first statement. There were many priests who came to Nazareth House to say Mass, hear confessions, take benediction or just to visit.

4. In paragraph 35 of my statement dated 19<sup>th</sup> September 2013 I set out details of abuse I suffered at the hands of Father SND 106 The Inquiry, in light

of the assertion by Father SND 106 s legal representatives that I am mistaken, has asked me to explain what occurred in as much detail as I can.

- 5. I recall that Father SND 106 was quite small and stocky. He had a very good head of dark hair and he had a round face.
- 6. The abuse I am referring to involving Father SND 106 took place on a bench beside a wall in the playground of Nazareth House. My recollection is that Father SND 106 visited the home often. He used to come out into the playground and would grab a child and bounce the child up and down on his knee whilst singing a song called 'there was an old woman who swallowed a fly'.
- 7. He bounced me on his knee on a couple of occasions. He held me tight and rubbed back and forth against me. He had what I now know to be an erection doing this. At the time I would have understood it as him having something hard in his trousers. I felt uncomfortable at the time because of the tight way he was holding me. When he released me I ran away from him down the playground. After the second occasion I stayed away from him in the playground.
- 8. My belief is that it must have occurred during the summer months as I recall wearing a light summer dress like the other girls. I was only about eight or nine years old at the time.
- 9. I did not tell anyone about this at the time as I feared I would be beaten by the nuns for telling stories about a priest and that they wouldn't believe me anyway.
- 10. I recall hearing other children say 'there is Father SND 106 when Father SND 106 would arrive at the home. He was known in Nazareth House as 'Father SND 106 or SND 106'.
- 11. I confirm that it is my belief that the priest who abused me in the manner described in paragraph 35 of my first statement was Father SND 106



The above named child and her family have been known to this department since 1965. There were many marital difficulties, particularly as was not keen to shoulder her responsibility in looking after the children. There was eventually a break up in the family and HIA 49 was received into care on 23rd May, 1966. Perental Rights Order granted in respect of her at the Juvenile Court on 6th December, 1966.

has from time to time contacted her requesting the childrens return but could never provide care for them. She was last reported to be living somewhere in the area

We were unable to find a permanent foster home for HIA 49 but during the Summers of 1967 - 69 she was boarded out for holiday periods. Until the end of 1969 HIA 49 was placed in Nazareth House, Londonderry. However, in October 1969 HIA 49 behaviour became so bad that Nazareth House refused to keep her eny longer. After extensive enquiries with all other Welfare Authorities a vacancy was found for HIA 49 at May-varren Children's Home, Portrush, and she was transferred there of 7th November, 1969. She cettled there for only a short time, and began misbehaving again in March, 1970. School reports during his time described her as a very difficult child who seems to have no respect for anyone and ignores the normal rules laid down for the running of the school.

On 7th April, 1970 it was learned that HIA 49 had been expelled from her school, as a result she was seen by who recommended that she should be examined by a psychiatrist. Accordingly she was seen by consultant psychiatrist, at his Coleraine clinic on 18th May, 1970. In his report he stated that she appeared to be a sensitive type who tended to bottle-up her faelings and become resentful of everyone around her.

On 26th July, 1970 HIA 49 rem away from the Children's home, and arrived at her sister's home in four days later, on 30th July, 1970. The was temporarily returned to the children's home. HIA 49 be boarded out with her for a trial period, and as a result HIA 49 was placed there on 7th August, 1970. Due to HIA 49 previous bad behaviour we were unable to have her admitted to Intermediate school. Eventually the sister in charge of agreed to admit HIA 49 to that school for a trial period.

to this department by (Educational Welfare Officer) for irregular attendance at school. The improved temporarily, but in November the sister in charge informed us that she was considering expelling HIA 49 from the school because of her bad behaviour and the bad influence she had on the other pupils. As a result of representations on our part HIA 49 was given another chance.

However, her behaviour continued to deteriorate, both athhome and at school. On 14th January, 1971 requested that we find other accommodation for HIA 49 as she could no longer cope with her. As a result HIA 49 was transferred to Our Wother Of Mercy Home in Newry. This is a special family group type home where HIA 49 was supervised by trained staff. The did not really settle and absconded from the home on 1st February, 1971. It transpared that HIA 49 had been causing trouble at the school she was attending as well as in the home. She was found in Londonderry and returned to the home for a further trial period on 3rd February. Her behaviour did not improve - she shows no respect for anyone in authority or anyons who is trying to help her. She bullied and terrorized the younger children at the school and eventually she was expelled from the school on 12th March, 1971. Moreover, the Home is no longer willing to keep her as she has been upsetting all the other members of the unit.

In my opinion this girl requires strict discipline such as she would ressive at a training school.

Re: HIA 49

Although I know you are familiar with recent events concerning HIA 49 I feel that some incidents should be brought to the attention of those responsible for her long term care.

Firstly, I must comment that if, as is usual, we had been asked for a home circumstances report, it is most likely that the unsuitability of present home - especially for a disturbed girl like HIA 49 - would have been available to the licensing committee before they made any decision. The placement ran into difficulties so quickly, and finally broke down, apparently irretrievably, that any hopes for resettlement within the family appeared to have disappeared. Under these circumstances, I think the original plan should be re-appraised.

I understand that the Social Worker who has been undertaking supervision on your behalf has given you her opinion, and I must reiterate this viewpoint and ask that the licensing committee is made aware of all these developments.

Although we have no personal criticism of her home, in all the circumstances we feel that she cannot be expected to have the specialised skill or resources to give proper support to a girl like HIA 49 who you have described as severely maladjusted.

HIA 49 s behaviour during her stay with her although indicates that all these behaviour problems are still present.

I should like to have your observations after the licensing committee have considered the situation.

4.	had relatively short periods in various parishes initially; however, he went on to spend more lengthy periods in Derry, Derry and County Donegal. His role as Parish Priest there latterly spanned some twenty years. In addition to his priestly role, he had a pastoral role, which saw him being supportive to various parish initiatives, including facilities for youth. There is no record of him having specific duties or responsibilities for Institutions or Children's Homes.
5.	Until the request made by the Inquiry, the Diocese of Derry had never received any complaint or allegation against SND 106. This allegation has, in line with the policies and practices in the diocese, been reported to the police and social services and SND 106 has been asked to step aside from ministry while an investigation is carried out.
6.	As there is likely to be an active police investigation, the Diocese of Derry would not wish to comment on the allegation as it would wish to ensure there is no interference, or perception of interference, in that investigation, thereby allowing the proper course to be followed.

7. The Diocese of Derry is actively involved in the programme of Safeguarding Children guided by the National Board for Safeguarding Children in the Catholic Church in Ireland and strives to achieve and maintain good practice in the area of child safeguarding as well as the area of safeguarding of vulnerable adults. We have an active link with the civil authorities and co-operate with them on any allegation and subsequent investigation.
