ADDENDUM TO WITNESS STATEMENT OF HIA 272

I, HIA 272 will say as follows:-

 Having taken time to consider the contents of my witness Statement dated 24
 February 2015, I wish to make an addendum to that Statement in order to
 provide details of other incidents which occurred during my time in custody.

Millisle Borstal

- 2. I absconded from St Pat's Training School in 1973 and when I was located I was remanded in custody to Crumlin Road prison. I was put in a wing of the prison which was controlled by Republican paramilitary prisoners. They controlled their wing of the prison and we had to abide by their rules. I found this particularly frightening as I was only 16 years old at the time and was imprisoned in a wing with bombers and gunmen.
- 3. I was there for approximately 2 months before I was brought back to Court and I was sentenced to Borstal and transferred to Armagh Prison. The magistrate accepted the evidence of two Christian Brothers who believed that Borstal was the best option as I was beyond their control and a bad influence on others in St Patricks. I spent three months at Armagh and it was a harsh but fair environment. I did not experience any bullying or sexual advances during my time there despite being one of the youngest there.
- 4. I was transferred to Millisle for good behaviour. However, I remember a few hours after I arrived I was told to get my new uniform and laundry by a member of staff called Mr Skillen who was known as "Punchy". He was bald

and stocky and looking me up and down. He was so close to me that I could smell his breath. He suddenly grabbed my testicles and head-butted me at the same time. I was so shocked that I just stood there and did not react. Another officer and prisoner were present and they laughed as well.

- 5. There was a large clothes dryer in the laundry and Mr Skillen and two other members of staff bundled me in to the machine and shut the door. One of them turned the machine on for a second and scared me to death. It was a terrifying experience and one which I will never forget.
- 6. I complained to the Governor about this incident the next morning. I was told that the matter would be investigated. At 10 am, I was allocated a job scrubbing floors. I was on my hands and knees for 8 hours. I had to scrub the dining hall from one end to the other by lunchtime. I scrubbed as fast as I could and I managed to finish by lunchtime.
- 7. The other inmates came into the dining room in order to have their lunch and afterwards they all went back to their jobs. However I was told that I had to scrub the dining floor again by LN 22. I told him that the floor had been checked and passed by another officer as clean. He grabbed me by my ear and brought me back to the dining hall leaving black marks on the shiny floor as he went. He kicked the bucket of dirty water over the floor and told me to get it cleaned up by suppertime.
- 8. I had to scrub it again with a 9 inch scrubbing brush, a bar of soap and water. I only had a piece of foam for knee protection. This routine continued for approximately one month and I was becoming depressed. My hands and knees and back were all very painful, although never painful enough to be excused from work. I could not believe an officer could be so callous.
- 9. After a month, I was told I was moving to another job. Initially, I was relieved, but in fact I was just asked to start scrubbing the front of the building by Mr LN 23. I was warned to look at the floor if any ladies came into the office or I would be punished. I was at breaking point at this stage. I complained to

one of the staff members, LN 24 as I felt I was being punished even though I had not done anything wrong. He shrugged his shoulders and said "We Officers stick together". I understood this to mean that my treatment was because I had reported Mr Skillen for assault.

- 10. After 2 months of scrubbing, I snapped and refused to do anymore. I was reported to the Governor and punished by receiving 5 days in solitary confinement and 28 days of loss of night time association. When I was in solitary confinement, I had to stand facing the wall for 2 or 3 hours at a time and answer questions on the Bible which was the only reading material I had.
- 11. When I was released from solitary confinement, I was placed in the kitchen helping out and I was happy there during the day. In the evening, I had to sit in a small metal box with a narrow seat from 6 until 10 pm for a month until by punishment was complete. It was called the doggie box as it was in the same shape as the starting boxes at a greyhound race-track. This was an isolating and depressing experience. I had no-one to chat to in the evening.
- 12. Millisle was rife with sexual predators at night time. I was aware of people being raped when the lights were out. I remember once I heard another inmate being forced to give oral sex to older inmates. This was never reported. I remember my time there as being hell. Eventually, I absconded and I spent the rest of my sentence in Long Kesh together with an additional sentence of 12 months for escaping from lawful custody.

We were sorry to lose Dr. McGarry and Mr. Rhodes both of whom resigned. Dr. McGarry was appointed to a post which fully occupies his time and Mr. Rhodes left to take over a business in England. We wish them every success in their new ventures. We were deeply saddened by the death of Mr. E.B. Mitchell, D.L., B.A. He was a gentleman in every sense of the word and had given long and faithful service. We sympathise with his wife and family in their sad loss. Mr. J. Smith, Cloughey was appointed to the committee during the year.

Reviewing Body.

Members of the Reviewing Body met monthly to consider the progress and response to training of all trainees.

Probation Service.


Visitors.

HIA272 and another trainee had been working in the kitchen making tea for visitors. When a check took place after visits were over he was reported to be missing. On investigation it was found that he had escaped by sawing through a bar in the window of the kitchen store.

The usual abscond routine was put into operation and the R.U.C., informed but to date there has been no trace of the trainee.

The Finistry will be kept informed of any further developments.

I am a Constable of the Royal Ulster Constabulary, stationed at Donaghadee, Co. Down. On the 19th. March, 1974, I made a deposition at Newtownards Magistrates Court. I preferred the present charge against HIA272 and cautioned him. After caution and in reply to the charge, he said, "Nothing to Say." I have not yet completed my enquiries into the case and pray a remand until the 2nd. April, 1974, to enable me to do so.

I made further depositions at Newtownards Magistrates Court on the 2nd. April, 1974, and on the 16th. April, 1974, requesting further remands until the 30th. April, 1974, to enable me to complete my enquiries.

I refer to these depositions and further state that when I interviewed the defendant, HIA272 at Her Majesty's Prison, Crumlin Road, Belfast, on the 6th. February, 1974, in connection with the charge now before the Court, he replied, after caution, "I have nothing to say other than I wanted a transfer from the Borstal at

Millisle. *I declare that this statement signed by me is true to the best of my knowledge and belief and I make it knowing that, if it is tendered in evidence at a preliminary enquiry or at the trial of any person, I shall be liable to prosecution if I have wilfully stated in it anything which I know to be false or do not believe to be true.

Fit for Borstal Training.

FAMILY BACKGROUND

The defendant is the of a family of 2 girls and 5 boys whose ages range from 21 years to 6 years and normally resides with his parents in a 4-bedroomed Northern Ireland Housing Executive house at The home is said to be well kept. His father is in regular employment as his mother is engaged in household duties. The defendant's younger sister and 3 younger brothers are attending school.

RECORD OF EMPLOYMENT

The defendant has never been in regular employment.

BORSTAL GOVERNOR'S REMARKS

HA272 was received in the closed institution at Armagh on 15.2.73 and was transferred to Woburn House on 18.4.73. After a short period on general cleaning duties he was allocated to work in the kitchen. On Saturday afternoon 30.6.73 HA272 and another trainee had been working in the kitchen making tea for visitors. When a check took place after visiting time he was reported to be missing. On investigation it was discovered that he had escaped by sawing through a bar in the window of the kitchen store. He was unlawfully at large until 6.2.74 when he was apprehended by the RUC and remanded to prism. On 26.2.74 he appeared at Belfast Petty Sessions charged with offences committed whilst he was unlawfully at large and received a sentence of 4 months' imprisonment.

This young man never made any attempt to settle down in Borstal and was only waiting for the opportunity to escape. It was perfectly clear that he intended to follow the same pattern he set up in the Training School where he had already absconded about 26 times.

Considering the length of time HIA272 was at large and that he is now serving a prison sentence it is my opinion that Borstal is not the answer in this case. Some other form of custodial treatment will be necessary.

PRISON GOVERNOR'S

Non-co-operation; due to his attitude and the nature of the offence I cannot recommend Borstal Training.
