I then ran out of the room and through the middle dorm and down the fire escape and ran into the woods and waited there until about 10 o'clock and I went to DL 218 DL 218 home where her father let me stay for a few days and then he brought me back to the home. I told DL 218 what had happened to me when I was staying with them, nothing else happened to me when I was in the home and I was discharged in [REDACTED]

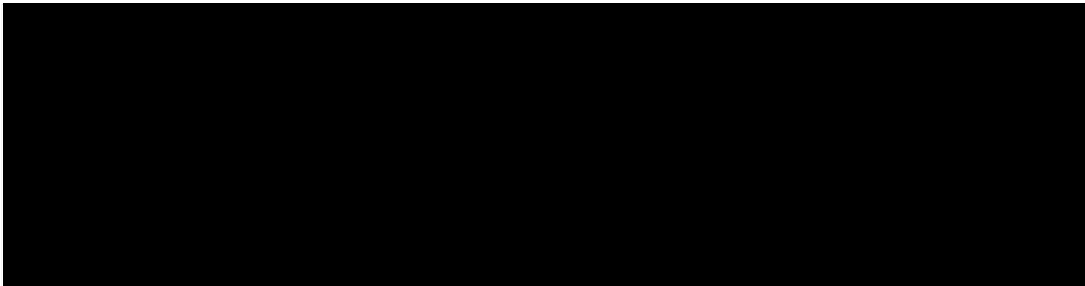

[REDACTED] I was sent to De La Salle Boys Home in Kircubbin. My brother [REDACTED] DL 206 who was older was already there and [REDACTED] DL 231 and [REDACTED] DL 133 who were younger than me, came along later. Although Nazareth Lodge was fairly strict I had a reasonable enough time there. When I went to De La Salle I was put into a dorm at the old school with about eight other boys. There was an older brother called [REDACTED] BR 6 nicknamed [REDACTED] BR 6 who was in charge of us. I stayed in this dorm for about [REDACTED] months after that I was moved up into the [REDACTED] to a dorm upstairs with about 15 other boys. That where things started to happen. Next door to this dorm I was in, was a [REDACTED] BR 15 s bedroom. [REDACTED] BR 15 was in charge of our dorm. [REDACTED] BR 15 would come in at night to make sure everyone was asleep. He would come over to my bed the first time it happened. I was sort of semi asleep. He put his hand down my bed under the

blankets and sheets. He started to fondle me around my private parts by that I mean around penis and balls, I by this stage was fully awake. I asked what he was doing. He said he was checking to make sure that I hadn't wet the bed. He just sort of left after that.

This same type of thing, him feeling me, continued over a number of more nights, although nothing was said by him or me about what he was doing. I didn't ask him to stop because I knew that it would mean getting a slap. This had been going on sort of regularly for just over a week and by that stage I suppose I had got sort of used to it. Anyway one night I suppose I got excited, by that I mean I got a hard on. He, that is **BR 15** felt this and he immediately ordered

me into his room, which I said earlier was next door. Although I didn't see any of the other boys looking, I'm sure they knew what was going on. **BR 15** took me into his bedroom. I was in my pyjamas, he started to fondle me again and he pulled the string on my pyjamas which made them fall down. He kept on fondling me and then he asked me to sit on his bed, he then took my hand and put it under his robe and made me fondle him, he was naked under his robe. He made me rub him off until he came over my hand. He then made me wash my hands in the little sink that he had in his room. Then he sent me back to my bed. He never said anything except to go back to my bed. This same type of thing went on for most of the time that I remained in De La Salle. Although when I started to get a bit older and wiser, I just started to refuse him, but he certainly abused me nearly 6 days a week for a few years. The only time he didn't do this was if we went away for summer trips or out at the weekends. **BR 15** would

also abuse me in the Laundry which was to the side of the main house.

[REDACTED] BR 15 was [REDACTED] and he got me a job in it.

He abused me about 6-7 times in the Laundry, this was doing exactly the same as he was making me do in his room, that is really pulling him

off. Just down from the Laundry was a like a tiny little workshop

where we used to mend like musical instruments. [REDACTED] was run

by a [REDACTED] BR 28, it was his [REDACTED] A few times that I was

walking past [REDACTED] BR 28 called me in. The first time when he got

me into the workshop he started to talk to me about sex, he was sort

of telling me the facts of life. It was during this that he started

to fondle me. I was wearing shorts, as we always did, he put his hand

up the leg of my trousers and he fondled my privates, at the same time

he had his other hand through the pocket of his robe and appeared to

be rubbing himself in the area of his privates. That went on for a

few minutes then he stopped and told me to get back to what I

was doing. He never said anything to me about keeping quite. I just

knew not to say anything. This same thing with [REDACTED] BR 28

happened to me in the workshop on about 5 or 6 different occasions,

each time he also talked to me about the facts of life. The only

other person who did anything to me sexually there was [REDACTED] BR 6

who was [REDACTED]. This is not the same [REDACTED] BR 6 I

mentioned earlier in my statement. I must have been about [REDACTED] or

thereabouts. I was playing Hurley one day and I got a crack on the

leg with a hurley stick. When I done my leg which was badly bruised

just down below the knee, [REDACTED] BR 4 put on cream and a bandage

on it. A few days after this [REDACTED] BR 6 asked me how my leg was.

He asked me into his office, which was in the school, to have a look at it. I did this and in his office he told me to take down my trousers and pants. I had thought this strange because I was wearing short trousers and the injury was below my knee. He touched around the area of the injury and then worked his way up higher until he started to fondle about my privates. He fondled about the area of my privates for a couple of minutes and then told me to pull up my trousers and leave. Again, as with the other, he never said anything to me.

[REDACTED] BR 6 did this same thing to me on about three different occasions during the time I had the sore leg. These are the occasions that I was abused, but I was aware that other boys were being abused as well, even though I didn't actually see it happen. I just seen the after effects. By that I mean I seen kids who had just been with certain Brothers and were crying, upset and if you asked them about what had happened, they just clammed up, just wouldn't say nothing about it. I can't remember all the boys names who I firmly believe were also abused, but I do know in my own mind because I was there and seen what went on, the aftermath and that, that my brother [REDACTED] DL 206 a boy [REDACTED] DL 207, who lives somewhere about [REDACTED] and a boy [REDACTED] DL 208 were among those who were abused by a number of the Christian Brothers. During my entire time at the home I was also subjected to physical beatings by a number of the Brothers. I particularly remember a [REDACTED] BR 3 who was very violent, he would hit you with sticks or straps, not caring where he hit you. On many occasions I was left with bad bruising. I remember on one occasion [REDACTED] BR 3 beat me for over an hour and left me with bruises

I am the above named person and I reside at an address known to the police. In [REDACTED] or [REDACTED] I was placed in De La Salle Boys Home in Kircubbin, Co Down, Northern Ireland, as a result of family problems. On arrival I was placed in the main house along with [REDACTED] DL 198 and [REDACTED] came to the house later. Other persons there were [REDACTED] DL 244, [REDACTED] DL 245 and a [REDACTED] DL 246. Life at the home was very bad, the Brothers were always assaulting the boys. I seemed to be assaulted almost every day. We were punched and kicked for very minor things. A boy named [REDACTED] DL 201 was beaten once until he passed out. He was assaulted by [REDACTED] BR 6 and [REDACTED] BR 2 and the reason for the beating was he had run away from the home and later been caught. One winter I can't remember the year, I was assaulted by [REDACTED] BR 15 outside the tea room. He hit me on the right side of my head behind my ear, he did this because I swore at one of the Brothers earlier in the day. I was not given any treatment for the injury to my head. I was also denied medical treatment after injuring my right hand while playing hurley. I should add that when [REDACTED] BR 15 hit me outside the tea room he hit me with a hurley stick. Whenever he hit me there were a number of other boys

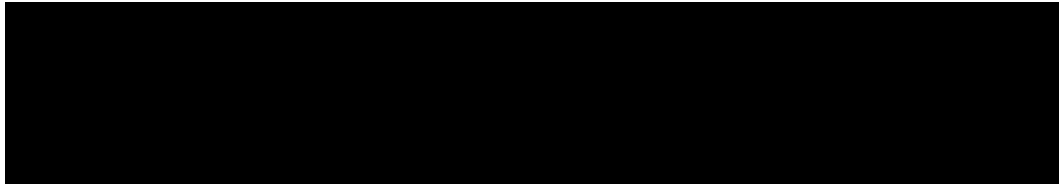

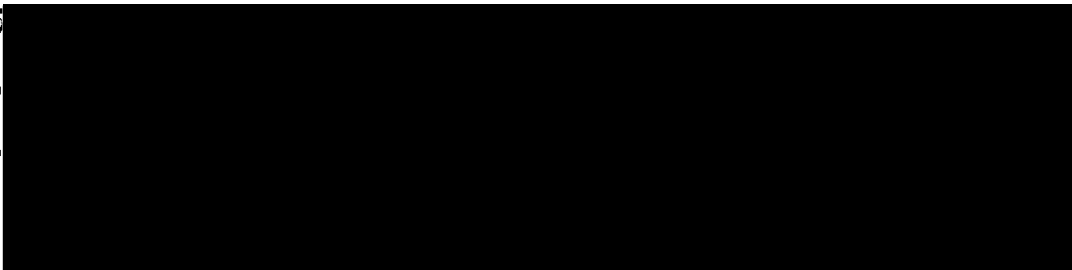

[REDACTED] In **[REDACTED]** I was sent on to De La Salle Boys Home in Kircubbin, Co Down. During my time at De La Salle I had some good times and some bad times. I was beaten by **BR 6** with a cane, he was **[REDACTED]** when I was there. He beat me about the body with a cane in the dining room and the showers, everywhere. He beat for things like leaving the school grounds and for fighting in the playground. He also beat me for not eating up my meals quick enough. I was also beaten by a **BR 15** **BR 15** with a rubber strap. He beat me for not hurrying up in the showers. He gave me a very bad beating one day for leaving the grounds and going to the local sweet shop. **[REDACTED]**

also spent a lot of time in the television room at the main house. It was always packed. In the evenings we would get out of our day clothes and put on our pyjamas. We would walk over to the main house to watch TV. One Brother who always appeared to be there was [REDACTED] BR 6

[REDACTED] BR 6 You were not allowed to smoke in the television room but [REDACTED] BR 6 always let you away with it. He would come into the television room when we were there and would ask us to sit with him. He didn't want us to sit beside him he always wanted us to sit on his knee. Whenever we sat on his knee he would give us sweets. He would often say to me "Come on over a get a sweet here [REDACTED] DL 195" Whenever I sat on his knee he would put his hand down the front and back of my pyjamas. He would feel round my privates and backside. I told him not to do this but he just kept on doing it. There was no one we could go to to complain because we didn't know what would happen to us. As well as doing it to me I saw him doing the same thing to other boys. He was always at it whenever people were in the TV room trying to watch the TV. Whenever he was doing this to me he would tell me not to say what was happening. I didn't like what [REDACTED] BR 6 was doing to me things like sticking his finger up my bum but I couldn't stop him. I was afraid of getting a beating. I would say that this went on for [REDACTED] and it then stopped all of a sudden. I heard that [REDACTED] BR 6 had been threw out of the home because of what he was doing. All of this happened to me in the main house and nothing unpleasant happened in the chalet. [REDACTED] During my time at De La

Salle I never saw or heard of anyone called Father Brendan Smyth. I should add that it was the rules of the house that you had to get

I was born on the [REDACTED] and I currently live at an address in [REDACTED] known to police. When I was about [REDACTED] years old I lived with my family in the [REDACTED]. I can recall I got into trouble stealing a car or something and I was sent to the De La Salle School in Kircubbin. When I went there I was put into a dormitory in the main house. I can recall that **BR 6**

was [REDACTED] at that time. I also remember a Brother

BR 15 was there as well. The only other persons I remember being

there was boys called [REDACTED] and [REDACTED]. I think [REDACTED] was from [REDACTED] I

can recall that when I used to get into petty trouble nothing much was

said to me at the time but later when I was in the dormitory at bed

time, **BR 6** would call me into his bedroom which was beside

my dormitory. He would tell me to take my pyjamas bottoms down. He

would help me to do this and then he would make me bend over the bed

and would hit me over my arse with a bamboo cane. I can recall on

occasions that he would draw blood when doing this. At this time it

was well known that **BR 6** done this to most kids at night

time and you knew when you were called out of your dormitory you were

in for a hiding. I can recall on other occasions **BR 15** would

call you into his bedroom and would try and teach you things from the bible. When he was doing this he would fondle me around my 'privates' area and put his arm around my back. I remember feeling uncomfortable about this at the time but there was no one around I could tell you just had to accept it. I recall on another occasion there was some trouble with the house wardens who looked after the chalet. I think the police were involved in it. I remember at the time the trouble was something about touching up the kids. During my stay in the De La Salle home which I think was [REDACTED] no Social Worker ever called to see me or visit me that I can remember.

In [REDACTED] I think it was the summer time, I was put into care because my mother couldn't cope. I was placed into a house on the [REDACTED] and stayed up until [REDACTED] when I was moved to De La Salle in Kircubbin. I remained there until I was school leaving age about [REDACTED]

[REDACTED] During my time in De La Salle I remember being beaten on numerous occasions virtually once a week each of these beatings were for minor wrongs that I done, like stealing a piece of food from the pantry or back cheek, each beating was very severe. I was beaten with

bamboos, walking sticks, leather straps with lead in them. These beatens were done by [REDACTED] BR 4 [REDACTED] BR 6 [REDACTED] BR 18 and [REDACTED] BR 2 [REDACTED] The number of beatings I got were so regular that I can't remember each detail. During my stay at De La Salle I was sexually abused on about 4 occasions, each time I was taken down to the derelict houses at the farm. I would be dragged down by [REDACTED] BR 4 and [REDACTED] BR 2 [REDACTED] and on one occasion by [REDACTED] BR 18 [REDACTED] I was then beaten or sexually abused or both. My trousers and pants were taken off me by one of them, I don't remamber which. The first time this happened, [REDACTED] BR 4 [REDACTED] dragged me down, [REDACTED] BR 2 [REDACTED] and [REDACTED] BR 6 [REDACTED] were also there. One of them took my trousers and pants off and

while one wanked me off one of the others pushed his dick up my bum. When he was finished he would swop around and he would wank me while one of the others pushed his dick up my bum as well. Each of them had a go at doing this. This same thing happened to me on 3 or 4 different occasions. It was always in punishment for something. I remember my backside was bleeding, but I was afraid to ask for a doctor because they wouldn't call one anyway. From I have left De La Salle I have had a nervous disability and relate this to my treatment in De La Salle. I can't remember all the exact details of each time that I was abused in the derelict house, it is so long ago and I have tried to forget all about it. I can say however, that those who actually put their dicks up my bum and wanked me, was **BR 6** **BR 2**

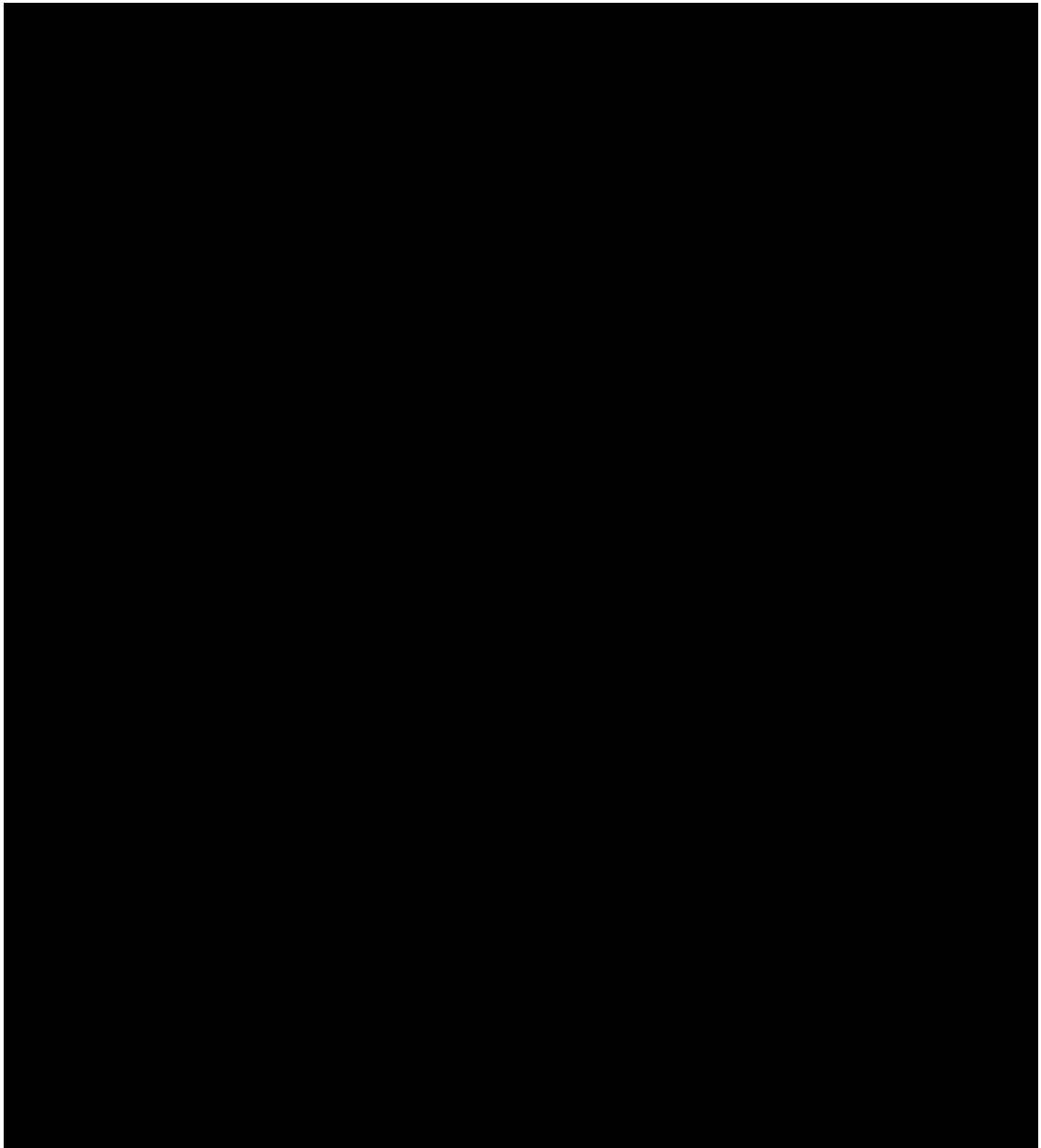

Each time he did this to me I was sore all over and usually cried a lot. I started to sleep with my clothes on. [REDACTED] BR 15 was [REDACTED] I think he

[REDACTED] BR 6 who was [REDACTED]
[REDACTED] He was [REDACTED] and he never wore [REDACTED]

[REDACTED] Over a period of [REDACTED] he bugged me twice. That happened once in the clothing store and once in the hay loft. All he did on both occasions was take my pants down and made me lie down in the hay in the loft. I remember he was very rough too. I have always believed that [REDACTED] BR 15 and [REDACTED] BR 6 were bugging my mate [REDACTED] DL 214 as well although [REDACTED] DL 214 never said anything to me. I never told [REDACTED] DL 214 what was happening to me. On one occasion when I was home in [REDACTED] for the weekend I told my mother what was happening to me in De La Salle and when I told her she sent for a priest - [REDACTED] DL 215. [REDACTED] DL 215 When [REDACTED] DL 215 came both him and my mother talked in a room in private and when she came out she told me I was telling lies and before the priest left he said to me that I was going back to the home and not to tell lies anymore. When I got back to the home it

was very quiet and I think they knew I had told about what was happening. They were very nice to me, too nice, they let me make phone calls home and sat over me while I was talking on the phone watching what I said. I had never previously been allowed to make phone calls home. After a few weeks back in the home however it

[REDACTED] Both of these statements are true. I have been asked if there is anything else I can remember about my time at the school. I can

remember running away from the school on one occasion. I was about

[REDACTED] at the time. I was caught in a short time by the teachers.

Later that day I was in class, [REDACTED] BR 6 was taking the class.

He brought up the subject about me running away. He said about

hearing I had a wee trip. I was cocky back to him. He hit me around

the back of the head a couple of times with a wooden metre ruler. He

did this in front of the class. He didn't mark me but it was very

sore at the time. I can also remember Brother [REDACTED] BR 77 giving one of

the boys a beating in the changing rooms one morning. It was couple

of days after the basket ball match I mentioned in the other

statement. [REDACTED] BR 77 and this boy had an argument after the basket

ball match and I believe [REDACTED] BR 77 beat him up to make an example of

him. He beat him so hard that the boy was bleeding I can't remember

the boy's name. As a result of going to De La Salle I would say it

remember is BR 6 hit me on the back and legs with a cane.

This happened in front of the class one day. Nobody else has ever put

I took my trousers off. He started wanking me. He then made me wank him and suck him off. He came all over my hand. While I was wanking him he felt around my bum. I can remember him spitting on his middle finger rubbing it around my bum and putting it inside my bum. I can remember telling him it was sore and that's when he stopped and told me to put my mouth around his dick. When he finished he gave me money. It was all change I can't remember how much. He gave me fags as well. Then he left. This happened about two or three times a week. It was

always in the Chalet and once in the Laundry Room. I can remember telling [REDACTED] BR 6 at the start what was happening to me. He told me I was talking nonsense and didn't believe me. I told my Social Worker in [REDACTED] and my mother. They didn't believe me either. I can't remember the Social Worker's name. [REDACTED]

[REDACTED] I also told the [REDACTED] a couple of years ago. I kept running away from De La Salle because of what was happening to me. I was brought to Court and was put into St Pat's in Belfast. There was chat that [REDACTED] BR 1 was a fruit. He never touched me. The only thing I can remember about him is he took down my trousers on the stairs of the Chalet and hit me over the arse with a bamboo cane. I think he hit me because I was late for tea or something like that. I also got slapped around the face and canned by other Brothers for not doing what I was told. This happened to all

Yes you say somebody maybe put pressure on them to make complaints against you. Why would anyone do that.

Don't know really, I couldn't answer that question, no I couldn't answer that question.

Well generally with regard to all of the complaints em we're about to terminate the interview. Is there anything in particular that you would like to say in conclusion em with regard to what has been said about you.

Well as I said before and there I repeat again that all the allegations made against me are untrue. I completely deny each and every one of them.

Uh huh.

BR 6

They are so ridiculous that they're beyond my comprehension.

Right.

Right, what he's saying there is that you made him suck your penis on a regular basis, that's the first thing he's alleging.

Completely ridiculous.

OK, the second thing he's saying there is, that he had to masturbate you and suck you, namely suck your penis until you ejaculated into his face.

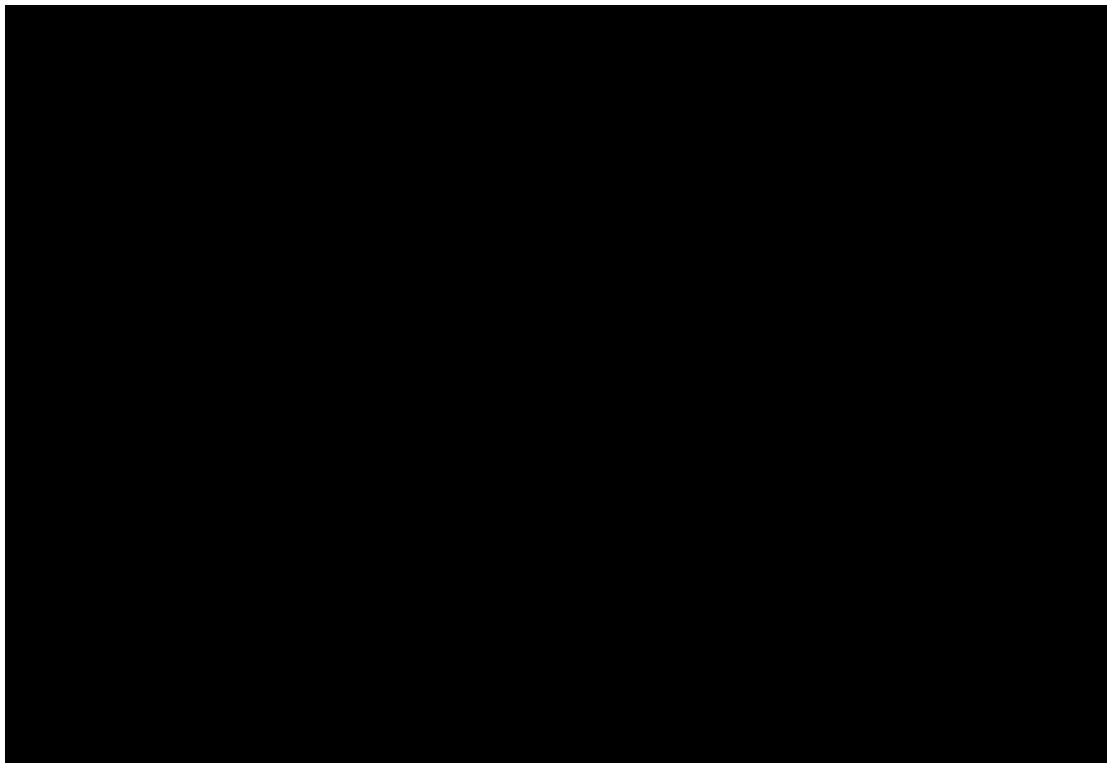

10. Charges 27-29 are sample charges of buggery by **BR 6** on **HIA 26** during the time he was in the home. Charge 30 refers to the buggery at Glenariff.

11. Charges 31-33 are sample charges of indecent assault by **BR 6** on **HIA 26**. **HIA 26** alleges three different types of assault, namely assaults during 'medicals', assaults in the shower and forced masturbation, and the charges are directed to reflect one example of each.

11. Charges 34 and 35 are sample charges of indecent assault by **BR 6** on **DL 200**. They are dated on the basis of **DL 200** statement that he was **DL 200** or thereabouts when he hurt his leg, and the indecent assaults occurred while he had the sore leg.

13. Charges 36-39 relate to the four offences of buggery alleged by **DL 198**, which he says occurred between the ages of **DL 198**.

14. Charges 40 and 41 are sample charges of indecent assault by **BR 6** on **DL 198**.

15. I direct no prosecution for other offences disclosed.

18. In the cases of **DL 69**, [REDACTED], **DL 49** and **DL 147**, Senior Counsel has consulted with each of them, and has advised. It is considered that there is no reasonable prospect of a conviction.
19. As regards **BR 6**, in the cases of **DL 193**, **DL 196**, **DL 64**, **DL 201**, **DL 60**, **DL 66**, **HIA 41**, **HIA 147** and **DL 213**, I agree with the police view that there is no reasonable prospect of a conviction for the reasons set out in the police report.
20. In the case of **DL 195**, he was invited twice to attend consultations, and failed to appear on either occasion.
21. At the date of this direction, neither **BR 1** nor **BR 6** has been interviewed about the additional allegations made by **HIA 26** in his statement of 11 November 1996. It is considered that they have both already made clear their position in respect of all the allegations against them, and that a further interview is unnecessary for the purposes of taking the decision as to prosecution. If police wish to interview **BR 1** and **BR 6** to allow them an opportunity to put their denials of these additional allegations on record, that can be done and the records of the interview served as additional evidence.
22. Investigating police have been asked to obtain evidence to prove the dates of those boys who were the subject of buggery.

Committal papers, Directions for committal proceedings, the police investigation file and a copy Direction Part I have been handed to the police officer in charge of the case and he should deal with them in compliance with RUC Force instructions.

Disclosure of unused evidence and information from the police investigation file will be made to the defence at committal. A copy of the disclosure letter is enclosed.

The investigating officer was requested by letter to provide schedules of all other material in the possession of police which has some bearing on the offences charged and the surrounding circumstances of the case. Consideration will be given to disclosure of that material once the schedules are received.

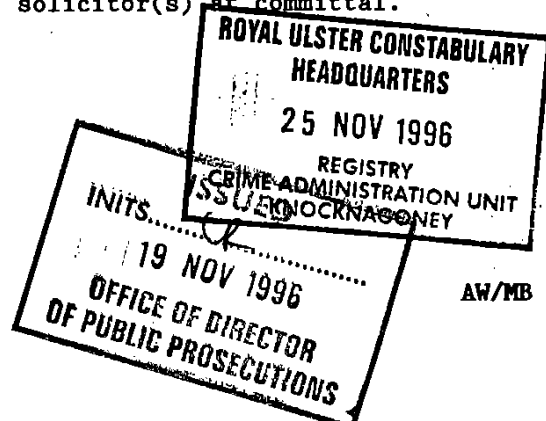
The Director's Consent has been granted in respect of charges 1-3, 10, 14-17, 27-30 and 36-39. Copies are enclosed.
