WITNESS STATEMENT OF	NL 114

## I, NL 114 will say as follows:-

- 1. I have been provided with a Witness Statement by HIA 10 and a Witness Statement from Sister Brenda McCall. I provide this Witness Statement in response.
- 2. I was born on I attended Secondary School in and left school at aged 16 years i.e. May 1977.
- 3. A Careers Teacher at School recommended that a summer job at Nazareth Lodge in Belfast and I took up this post as I wanted to go to Rupert Stanley College in Belfast to do a childcare course at the end of August. When I was due to leave Nazareth Lodge I was asked by the Head Nun to stay on and I did so rather than go to college.
- 4. I left Nazareth Lodge in 1987 to look after my mother who had heart failure.
- 5. My job at Nazareth Lodge was known as a house parent and there were five sections of about sixteen children in each. In respect of each of these sections there would be a nun in charge and four house parents who worked in shifts, two house parents to each shift. There was myself and NL 150 and two other house parents called NL 212 and NL 213
- 6. There were sixteen or seventeen children in my Section, the youngest child about 5 years old and the eldest 18 years old.

- 7. The two house parents on duty would get the children out to school in the morning with the help of the nun in charge of the section and this was Sister SR 46 initially and later SR 222 Sometimes a SR 156 would also help out. After coming on duty at 7.30 am you would get the children dressed for school and then take them down to the dining room for breakfast. After breakfast one member of staff would wash the dishes and the children had a rota for drying the dishes. The house parents were back on duty roughly about 1pm to prepare for the children coming back from school.
- 8. We would have walked down to St. Michael's Primary School to pick up the younger children but the secondary school children walked home themselves. At about 3.30pm the children changed out of their uniform into their casual clothes and then got tea and biscuits.
- 9. After the children had the snack the house parents and one of the nuns supervised homework. This would normally be SR 2 and they watched some television until teatime at 5pm when they got a full meal and then there was outdoor play.
- 10. I would have gone off duty at 9pm, the younger children having been put to bed but the children would still have been up.
- 11. I remember HIA 10 (now HIA 10 as having been in my charge. I remember her as having been one of three sisters at Nazareth Lodge. I don't remember precisely when HIA 10 came to Nazareth Lodge except that she was the youngest of the three children, NL 130 being the oldest and NL 87 the second children.
- 12. During my time at Nazareth Lodge there was some re-organisation in that the five separate groups became three separate groups. I don't remember having much contact with HIA 10 in later years because I was in charge of a different group of children.

- 13. I have read the Statement of HIA 10 and I have no recollection whatsoever of curling tongs ever being used as Nazareth Lodge. I deny that I ever used curling tongs on HIA 10 hair or on any other girl's hair.
- 14. My recollection is that with the older children we had no involvement in their bathing and they would have gone to the shower themselves and tended to their own hair.
- 15. Nor can I remember the children's hair being checked for lice and I never did nor did I use a lice comb.
- 16. In relation to the allegation concerning an incident in a lift I was never in a lift with HIA 10 I do not recall any child being in the lift, which was the lift was to the front of the Lodge and visitors used the front entrance.
- 17. The only time I used the lift was for taking the meals trolley up to the children for the serving of their meals upstairs. No child accompanied me in the lift to take up the meals trolley. I do not believe the children themselves used the lift as they came in the backdoor from school.
- 18. I deny that I assaulted HIA 10 I did not slap her on the face and did not tell her that no one cared about her, no one wanted her, or that she was worthless and would amount to nothing.
- 19. Similarly I did not ever see NL 150 assault HIA 10 nor make such comments to her.
- 20. In my experience the children under my care were very well looked after and well resourced with pocket money and leisure activities.



I, SR 46 , will say as follows: -

- I have been shown a number of documents numbered SNB 60174-SNB 60254.
   These are records of police investigations carried out some time ago and include a number of allegations and a copy of my interview notes.
- I confirm that the response I gave then to the allegations of at pages SNB 60206 – SNB 60210 are the same now as then. I have no recollection of any report of this kind. I also have no memory of any meeting of the girls as described.
- 3. I have also considered the allegations made by NL 88 I remember NL 88 and her brother NL 59 her twin and also her older brother and younger brother NL 88. She was a very pleasant, friendly girl. I think she is now working as a psychic. I recall an incident when I saw a love bite on her neck and asked her about it. She denied it at first and then asked how a nun would know about things like that. I explained that I was not always a nun. I reported this to her social worker who then investigated the incident and it turned out that her father had been abusing her. Social services became involved and there were restrictions imposed on his visiting and he reacted very badly. On one occasion he was grabbing me by the shoulder and a staff member, NL 114 saw him through a window and ran down the stairs to make sure I was ok and told me I was needed somewhere else. NL 114 then told me she had lied as I was not needed but she was just concerned about me.
- 4. I do recall an incident where NL 88 complained about Brendan Smyth. Again my memory now is pretty much what I recalled in my police interview. I recall NL 88

ruler with white stitching which she hit us with. If she wanted to hit you she would grab anything that was nearby. We were also hit with bamboo canes. The nuns favoured the children of families who had money and the families who appreciate how their children were looked after.

- 8. NL 150 and another member of staff called NL 114 would curl your hair and they would burn the back of your neck with the curling tongs intentionally. When checking for lice, the staff used a silver lice comb, but they did it so hard, it left me with scares and cut on my head and neck. I remember bleeding, and seeing other girls bleeding.
- 9. NL 114 was a terrible person. I was in the lift once with her and NL 150 I mentioned my grandmother and said she was dead. I was then slapped on the face and told that no one cared about me, no one wanted me, that I was worthless and I would amount to nothing. I was told the same thing all the time.
- the evenings with sweets and get us to rub his shoulders and his feet. He had wondering hands and I tried my best to stay away from him. He would play with your hair and then rub his hands down your back and then move round to your front and I would then wriggle away. He would pretend to tickle us, and then accidentally touch your chest, and his hand was always around your bum. There was another grounds man called NL 151 and my sister NL 130, told me that he interfered with her. He used to take her out on the bus and that it was when it happened.
- 11. My uncle came to visit us on a Sunday and he would bring three packets of polo mints. He was not allowed to take us out at the start. He would just sit with us in the Lodge. They made us sit in a foyer, close to the living room, so there was always someone from the Lodge around and we could not talk freely. There were a couple of occasions when we were allowed to go to his house. I do not remember my brothers ever coming to visit.

05.04.84	Nazareth visit. Time spent with NL 215 and HIA 5 -didn't take them out-gave sweets-pleased. All seemed well. Boys asked to go home at weekends.
03.05.84	Contact with Harberton school principal re. HIA 5 Settled-pleased with progress.
