WITNESS STATEMENT OF HIA 29

I, HIA 29 will say as follows:-

Personal details

- 1. I was born on I had four older sisters called NHB 66 NHB 67 And NHB 65 My younger siblings are called NHB 68 and NHB 69 I also have another brother called NHB 70 who went to live with an Aunt in England when he was a baby. I never knew him.
- 2. My mother and father were not getting on well together. I think they were having money problems so they placed HIA2 and me with my Aunt on the Road. NHB 65 went to live with a family friend. NHB 68 stayed with my father and NHB 66 stayed with my mother. NHB 67 went to live with another Aunt on I am unsure of circumstances of how I ended up in care but HIA2 NHB 65 and I were placed in Nazareth House.

Nazareth House, Belfast (18/07/1960 - 19/12/1965)

3. I was placed in Nazareth House, Belfast on 18th July 1960, when I was seven years old. HIA28 was ten and NHB 65 was almost nine. I did not know I was going there. I remember I had just taken my first Holy Communion. My mother, NHB 66 and my granny took us to Nazareth House. My granny turned back on the way there as she could not bear to see us go in. When we arrived we were

taken in to a big room with a big shiny table where we were met by SR 176 the Mother Superior.

- 4. SR 31 then took us to another room where she put white stuff on our heads that burnt, then she cut our hair in a bowl cut and then I think we were stripped and bathed. We were then taken to our dormitory. We were in the Our Lady's dormitory. It was a big dormitory with thirty or forty girls.

 SR 31 was in charge of our group. I think she would have been in her forties.

 SR 134 was in charge of the Sacred Heart group and SR 116 was in charge of the St Anne's group. The three of them also taught at the school. They were all wicked.
- 5. I think my sister NHB 69 who was five years younger than me, was placed in the nursery part of Nazareth House when she was a baby. I did not know her or anything about her. I did not know that she was in Nazareth House until one day, shortly after I went in, when I was out playing. There was a gate that separated us from the infants and I was standing beside it when a girl came over to stand on the other side of it. I asked her what her name was and she said NHB 69 was an unusual name so I knew she was my sister.
- 6. The three groups had a morning routine which rotated. Our group went to morning Mass one day, another group the next, and the other group the day after that and then it was back to our group. On Mass mornings we got up at about 6am to go to chapel. The other mornings we got up about 6.30am. If we wet the bed we were beaten. I remember being beaten for wetting the bed once by SR 31 with her keys. Watching other girls being punished for wetting the bed was a common occurrence. They were beaten and on Mass mornings they were made to stand with the wet sheet over their heads until everyone came back from Mass. On non Mass mornings they could have been made to stand there for over an hour. The bed wetter's were made to put their dirty sheets in the laundry and make their beds again with fresh sheets. We then went for breakfast. On our way out from breakfast SR 116 gave us cod liver oil by grabbing us by the hair pulling our heads back and forcing it into our mouths with a big massive spoon. We then went to school. We had to wash

our uniform. We used to put our skirts under our mattress to keep the pleats in them. After school and on Saturdays we had chores and played for a while. My chores included cleaning, laundry and shovelling coal into the furnace which heated the home. We said the Angelus outside at 6 o'clock. We were then brought in for our dinner. If you did not eat your dinner SR 116 would clip you round the ear and then spoon fed you. Our lips would have swollen from the force of her digging the spoon in. Sometimes we did not get to go to bed until 10pm so we were always tired. We were late going to bed if we were cleaning somewhere.

- 7. We were always hungry. The food was not of good quality and there was not very much of it. There was a dog that lived at the home and the outside toilet was near where he stayed. I was so hungry that I used to hide in the toilet until SR 116 had fed him and then I would eat his food.
- 8. One day we were cleaning the floors in the dining room and I looked in to the big cupboard in the dining room and saw a big block of cheese. Another girl and I were so hungry that we ate some of the paper which was covering the cheese. When we chewed it it turned into chewing gum. We knew we could not eat the cheese as the nuns would have known if any of it was gone.
- 9. We were bathed every Saturday. Jeyes fluid was put in the bath which burned really badly. The three nuns took it in turns to be on bath duty on a Saturday.

 SR 116 was the worst. She used to use a scrubbing brush. She used it on our private parts to make sure we were clean. When we got out we were brown all over but we were not allowed to use clean water to clean it off. We just had a big sheet to dry ourselves with which we had to share and it was soaking by the time I would get it so I was not able to dry myself properly. The nun on bath duty used to check our necks to make sure they were spotless and if they weren't we had to go back in and clean them again. We had a rag that we used to clean our necks. We also had to use carbolic soap, we even used it to clean our teeth.

- 10. We had to work in the laundry. We washed all the clothes and bed sheets on washboards. When I came out I was soaking and in the winter I was also freezing. We did not get a change of clothes and we were expected to spend the rest of the day in wet clothes. We also had to scrub the floors in the laundry. We had to scrub the halls, the dormitory, the church and polish the pews in the church. There was a rota of what each group had to clean each week. We also had to clean the nun's room which was at the corner of our dormitory. I was cleaning in SR 31 room one day and I saw a framed photograph on her windowsill of a girl in her communion dress. I was shocked when I saw it was a photograph of me. I have no idea how she got it or why she had it.
- 11. I had to shovel coal into the furnace which heated the home along with another girl called It was frightening in there. People sent in boxes of sweets but the nuns said they were poisoned and made us burn them in the furnace. and I would eat the sweets before we threw the boxes in to the furnace. One day SR 31 came down and saw the colours from the sweets on our face. She took us to a room upstairs and caned us on the hands.
- 12. I remember sitting in the dining room with my sisters one day and SR 31 who had been in a terrible mood that day, came in a said that our parents had not paid for us so why should they feed us. I do not think we were fed that day. That has stuck in my head.
- 13. One day when I was playing in the yard with my sister NHB 65 I was standing on a bench which toppled over and I fell and hurt my back. SR 134 came over and I tried to tell her that I was hurt but I had been winded so badly I was unable to speak. She did nothing to help me, in fact she hit me on the side of the head with her knuckles for falling. NHB 65 had to look after me and lift me up and try to get me to walk.
- 14. I was never taken to hospital. I only saw a doctor once when I got my BCG. I remember another girl was taken to hospital once and when she returned she told us she had got beautiful food. So I swallowed a screw to see if I could be brought to the hospital but I was not taken. I was put in a room with just a bed

and had to wait until I went to the toilet and the screw came out. SR 134 came to ask if I had got the screw so I had to wash it to show it to her. She gave me a clip round the ear.


- 15. I went to primary school in Nazareth Lodge and then to St Monica's Secondary School on the Ravenhill Road. The other girls at school would call us names because we lived in the home. I remember walking back from school one day with another girl, whose name I cannot remember, and we went into a wee orchard and took some apples. We brought them back and shared them with the other girls. The owner of the orchard phoned the home and said that one of us had taken apples. The nuns told us that if the culprits did not own up that everyone would be punished so we owned up.

 SR 31

 put me in a big room and hit me on the hands so hard with the cane that I thought she was going to take my hands off. I remember my hands were swollen afterwards.
- 16. I remember one night when one of the younger children died and we all had to go down to the chapel to pay our last respects. I will never forget seeing her in her coffin. I think she had been out for the weekend with a family and had drowned
- 17. I remember another occasion when I was cleaning somewhere and had to walk up the stone steps to the dormitory. I fell and chipped my tooth.

 SR 116

 was walking behind me. She was crying because one of the older nuns had died. She pulled me up the rest of the steps by my hair. The blood was pouring out of my mouth. She did not care at all.
- 18. SR 31 was wicked. She used to hit us over the head with the keys she carried. I remember one day at school when I got my sums wrong she hit me on the hands with a big bamboo cane. She used to carry a cane on her person every day. Sometimes she used a black leather strap. I remember going in to the toilet one day and I had to run out immediately because SR 31 was beating a girl. She was squealing but I could not do anything to help her as I was just a child myself.



- 20. My mother visited us in the home most Sundays with NHB 66 I only remember my father visiting once or twice.
- 21. My mother and father got back together and got a house on the Road. They brought us back home. I understand that the registers show that I left Nazareth House on 19th December 1965 however I distinctly remember watching the World Cup final in 1966 in Nazareth House and SR 116 jumping for joy when England scored. I do not know the exact date we left the home.
- 22. I do not remember any inspections of the home.

Life After Care

- 23. When we returned home NHB 65 and I lived with my mother and father, NHB 69 and NHB 68 NHB 67 still lived with our Aunt and NHB 70 remained in England. NHB 66 had left to live in America.
- 24. I went to ______ on the _____ Life was great and I got on well with my mother and father. However, just as I thought life was getting better the "Troubles" started and life became difficult again. The nuns used to come round collecting money. I remember that any time we saw them we ran into the house and hid in the coal hole in case they were coming to take us back to the home.
- as a stitcher. I loved that job and I had friends. I continued to live with my mother and father. I then moved to Boston because I got a job as a nanny for a Jewish family who lived there. I stayed there for two years and I really enjoyed my time there. I returned to Belfast as the parents in that family separated and I was no longer needed. I

- 26. I no longer have any friends. I just have my son and my sisters. My sister NHB 65 lives across the street from me and we look after each other. I do not go out. I am close to my brothers and sisters.
- 27. The way we were treated and brought up was terrible. I believe it is the reason I cannot show affection. I am worried that i did not show enough love to my son It is difficult to love when you were never shown any affection as a child.
- 28. My mother died when she was 56. She was a drinker and my sister found her dead on the sofa one day. My father died when he was 53 of a heart attack.
- 29. I have reported the incidents which happened in Nazareth House to the police and they are currently investigating my case.
- 30. I believe that the victims, such as myself, should receive an apology from the Sisters of Nazareth and the State, compensation and there should be a memorial for those who have died before they were given an opportunity to tell their story.

I did, I had two actually, they were taken off in America.

She would say that, "I remember that I was fed poorly from day to day, I was given a piece", sorry 'piece' in inverted comma's, "Which consisted of a slice of bread with a slice of butter in the morning and very little for the rest of the day. On a regular basis I used to hide out near the toilets at about 1630 hrs", 4 30 for you and I Sister, "Close to where the dog was fed each day. I would sneak out and eat the dog food from the dog's dish because I was so hungry. I did this up until I was about 11 years of age", or sorry, "11 years old when I started secondary school at St Moncia's on the Ravenhill Road. I was able to get the food at the school then so I did not have to take food from the dog any more". That's obviously quite shocking to hear that myself, do you ever recall that at all?

A No, don't even remember a dog.

Q You don't remember a dog being kept at Nazareth at all?

A No.

Q Okay, and do you ever recall there being a lack of food for the children at all?

A No.

Q Would you...

A They were well fed.

Q You would say there was an ample, an ample supply of food?

A Ample supply.

Okay, she would say on another occasion whenever she was either 9 or 10 years old she would say about 1962 this would be, "I had fallen on the concrete steps in the house. I badly chipped my front tooth.
