I have a number of testimonials and references which I obtained in with my various applications for employment and these confirm my irregular employment at Nazareth Lodge in Belfast. 
- 4. The next one is dated 18<sup>th</sup> November 1975 and is signed by SR 47 of Nazareth Lodge and it states I worked for short periods as an assistant House Mother from July 1974 to September 1975. SR 47 then wrote a further reference for me which is dated 3<sup>rd</sup> May 1978 and refers to my work as a House Mother in Nazareth Lodge.
- 5. I am also enclosing two further references regarding my employment in South Africa. The first is dated 18<sup>th</sup> November 1980 from and the second is dated 1<sup>st</sup> December 1990 from City Deep Adult Education Centre. I also have a number of certificates for Child Care courses which I undertook in South Africa after 1975 as I preferred to work with young children, particularly those who were disadvantaged.
- 6. I would estimate that during the period between 1956 and 1975 I would have worked in Nazareth for less than half of this period and my best estimate is that if I totaled up all the periods I worked in Nazareth Lodge it would be between 7 and 9 years.
- 7. A number of allegations of child cruelty have been made against me. I was interviewed by the police about these allegations on 8<sup>th</sup> May 1996 and again on 19<sup>th</sup> October 2012. A number of people have also made statements to the HIA Inquiry. I deny I used excessive force or that I was cruel to any child. I also deny the sole allegation made by one former resident that I indecently assaulted him. Before I comment on the specific allegations, I intend to give some background information and describe the work I carried out at Nazareth Lodge.
- 8. Most of my work was with boys of primary school age, between the ages of 4 and 11. At some stage during the 1960s when I returned to Nazareth Lodge the decision had been taken to keep brothers and sisters together and so I would have had some limited contact with girls, but the majority of children I supervised and looked after were boys.
- 9. I was employed by the Sisters of Nazareth. They provided my board and keep and I received a very small wage. I normally stayed overnight in staff accommodation. Initially the staff members shared an attic room and sometime later proper staff quarters were provided. This was separate from the dormitories where the children slept.
- 10. I received no instructions or training during my work in Nazareth Lodge. I was given no information about any particular child. I worked under the direction of a nun who was in charge of each of the four groups of boys. I did not attend any meetings and no personal details about individual children were discussed with me. I did not meet social workers or get information from them when they called to visit children at the Home from time to time. I also received no guidance or instructions in relation to the discipline of children. When a child was unruly or misbehaved, I would have sometimes slapped them with my open hand. Normally I would have slapped them on their hands or their legs. On occasion I may have slapped them on their bottom. This was a spontaneous thing. I did not use excessive force or cause any bruises or marks on a child's body. I also used a ruler from time to time to slap a child but this would normally have been one or two slaps and again I never used excessive force. I did not carry the ruler around with me but would have picked it up if it was lying around. However more frequently I would have used my open hand to slap a child for misbehaviour.

- 11. In common with the other House Mothers, I worked very long hours at Nazareth Lodge. The day would begin at around 6am when I got up and after dressing I would go to the dormitory to waken the children. We all went to morning mass and then supervised the children at breakfast. After this the children would help us make their beds before going to school. If there was some spare time, I would ask the children to do other simple chores. Some of the older children would have been provided with cloths and told to polish the floors. They would have done this by putting the cloths on their feet and moving up and down. They did not have to get down onto their knees. This would only have been for 15 or 20 minutes. When the children were at school, I would have carried out general housework. This would include cleaning and sometimes ironing clothes. At mealtimes I would have supervised the children.
- 12. After school I would have continued to supervise the children and they normally went to bed between 6pm and 7pm. As some of the children were known to regularly wet their beds, I would have taken it in turns, along with the nun in charge of the group, to waken those children at around 9pm and bring them to the toilet close to the dormitory. If the bedclothes were wet, they would be changed and the soiled bedclothes left in a pile until the morning time. I would only have wakened up those children who were known to bed wet frequently. After this I had no further contact with the children during the night. A nun would have slept in a small cubicle or annex in the dormitory. Each of the four groups had their own dormitory and the nun in charge slept close by. If there were any further problems during the night, the nun would have dealt with it. My sleeping quarters were some distance away.
- 13. On Saturdays the children were sometimes taken to the Curzon Cinema on the Ormeau Road which was several hundred yards away. As the nuns would be out collecting money, I would sometimes have to supervise between 80 and 100 children by myself and bring them to the cinema on the Ormeau Road. I was always worried that something would happen to a child while I was taking such a large number out of the Home but thankfully nothing untoward ever occurred and I was always relieved when they came back safely. During the summer the children were taken away for a holiday for a number of weeks to Ballyhornan and if I was working there at that time I would have gone as well. There would have been nuns and other staff members there to supervise the children and I always recall the children were happy to get away during this time.

### – HIA reference 16.

- 14. HIA 16 made a statement to the Inquiry about his time in care at Nazareth Lodge and the police interviewed me on two separate occasions about his allegations.
- 15. HIA 16 came to Nazareth Lodge around 1959 and stayed until 1967. I was working at Nazareth Lodge for part of the time he was in the Home. For substantial periods of time, I was living and working in England and Wales, although there were periods when I was working as a House Mother and I recall HIA 16.
- 16. In his statement to the Inquiry he alleges I used to beat him all the time. He said it was an almost daily occurrence. He alleges I used a rubber bat and struck him all over his body. He claimed I would go around all the groups bullying the boys and would hit them and call them names. He alleged I used to argue with the nuns and the other staff as well.

He claims he had plenty of bruises on him but that he never received any medical treatment as a result of these beatings. He claimed I would make him sleep with his head under the blankets to make sure he would fall asleep quickly. I reject all of his allegations completely. I never had a rubber bat. I never used excessive force or was cruel to him as he alleged. It is quite possible I had to chastise him from time to time and although I do not recall it, it is quite possible I would have slapped him if he was unruly or was misbehaving.



- 18. I was employed by the Sisters of Nazareth as an assistant House Mother and then was described as simply a House Mother. In his statement to the police he states I came into his dormitory when he was asleep and took him out to the shower room. He said I then told him to take off his pyjamas and that I would then touch his private parts and after this I would beat him with a rubber bat all over his back which left him bruised and very sore.
- 19. He said this type of abuse which was both sexual and physical was carried out on a regular basis from when he was about six years up until he left when he was eleven. He alleged he was abused sexually in this way about twice a week. However none of this is even mentioned in his statement to the Inquiry. This appears to the most serious allegation he has made against me but yet it does not feature at all in his Inquiry statement. However what I recall is that HIA 16 defecated in his bed regularly at night. As I have already stated, it was normal practice for either myself or the nun to waken those children known to have a problem at nighttime.
- 20. Whilst the usual difficulty was that some children wet their beds at night, I specifically recall HIA 16 would have defecated in his bed. He might have been nine or ten years old when this happened and I recall he was difficult to deal with after this occurred. I would have to take him into the toilet and he would have refused to clean himself. I therefore would have had to wash around his bottom. For some reason he has chosen not to mention this in his statement to the police but instead has suggested I was sexually assaulting him for no particular reason. I am sure I was not the only staff member who would have had to wash HIA in this way.
- 21. In his police statement he describes what he alleges is the last beating he got from me. He stated this was on a holiday in Ballyhornan, Co. Down during the last year he was in Nazareth Lodge. He was 11 at the time. He claims that one day, for absolutely no reason, when he was talking to NL 6 I came over and grabbed him by the throat and pushed his head against a pebble dashed wall which resulted in the back of his head being cut open. He claimed blood ran down his back. He then was ordered by me to go and get a bath tub of boiling hot water but when he returned, assisted by HIA 21 he claims he threw some of the boiling water over my leg and that I started screaming and ran off. The two individuals whom he claims were present, namely have not come forward to corroborate his account.

- 22. Initially when the police described this incident to me I said it did not happen and could not recall anything about it. This was because the police were putting to me allegations that I had carried out an assault on HIA 16 for no reason which resulted in him sustaining an injury to the back of his head. He then retaliated by deliberately throwing hot water over me.
- 23. Having thought about the matter subsequently, I have now been able to recall some details which could be related to this incident but I deny completely any allegation that he was assaulted or indeed that he deliberately poured hot water over me with the intention of causing me injury. I recall there was no hot running water in the chalets at Ballyhornan and so when it came to bath time which was on a Saturday evening staff members had to carry or supervise boys bringing a large pot of hot water from the kitchen over to the bath tub. Some of the older boys would have helped me carry this large pot. I recall on one occasion a small amount of hot water spilled over my foot. However this was an accident. I believe HIA 16 was carrying this pot and that two other boys were involved. I believe one of them was HIA 16 but I am not sure if HIA 21 as also there.

24. HIA 16

he said he was part of the St. Martin's Group and that the nun in charge of his group was SR208

I believe he meant to refer to the Marion Group. I do not recall any working in Nazareth when I was there. There may have been an elderly nun called at one stage but she did not actually work with any of the groups. In his statement he describes regular assaults and that I used a rubber bat to beat him all over his body. He alleges he was covered in bruises and was very sore. He claims I used to call him nicknames like rabbit and buck teeth. These are matters which he also has described in his HIA statement but I don't recall using those expressions or nicknames about him. It is always possible some of the other children called him these names but I have recollection of this. He alleges he saw me and another House Parent assaulting other boys using a rubber bat, like a tennis racket but I deny this.

- 25. In paragraph 7 of his HIA statement he claims that after he wet his bed, I used to threaten to put him in the washing machine. This is not true. I am aware others have made a similar type of allegation and I wonder if HIA 16 has spoken to other former residents about this. He describes this differently in his second police statement. He claims he was brought down to the washing machine and told if he wet the bed again he was going to be put in the machine and that it would be turned on.
- 26. He concludes his statement by claiming he saw me about two years earlier on the Antrim Road. He said he couldn't approach me as he was still in fear of me to this day.
- 27. While I am not in a position to say whether or not he did in fact observe me on the Antrim Road in Belfast I do recall very clearly meeting HIA 16 around the mid 1990s. I told the police about this meeting during my interview on 8<sup>th</sup> May 1996. He was a taxi driver who I now believe was working for Gransha Taxis, and he picked two of my sisters and myself up from the Glenowen Inn on the Glen Road, Belfast after we had a meal. I didn't recognise him but after he dropped my sister off at her home he said to me that he knew me. I had a friendly conversation with him and when I got out of the taxi at my house he said it would be nice to meet up sometime and have a drink. He shook hands with me as I was getting out of the taxi. I remember he said of his time in Nazareth that it was hard with the nuns being strict and I recall saying to him it was hard there for all of us.

28. In his account to the HIA Inquiry, HIA 16 seems to imply that I beat him at times when the nuns were not around. He stated the nuns never saw the staff hitting him and that I used to wait until the nuns went to say their prayers before I came over to his group and started to beat him and the other boys. I note he has said in his statement that the nuns at Nazareth Lodge were all kind. However if the type of physical abuse he has described had in fact occurred, I do not believe it would have been possible for the nuns not to notice or be aware of it. In all of his accounts, he alleges I frequently left him bruised all over his body but yet no-one seems to have been aware of this and I was never reprimanded by any of the nuns for using excessive force or cruelty on children.

### - HIA reference 19

- 29. I have read the statement of HIA 19 to the HIA Inquiry which is dated 17<sup>th</sup> March 2000 (?) and I am also aware he made a statement to the police on 28<sup>th</sup> April 2010. I was interviewed by the police regarding his allegations on 19<sup>th</sup> October 2012.
- 30. In his HIA statement he claims both NL 5 and I would take boys into the laundry and that we would lift them, put them into the machine and close the lid for a few minutes and threaten to turn it on. He said he thought we did this as a deterrent to those boys who wet the bed. I note he refers to the boys as "us" and doesn't specifically refer to himself when he describes this and he doesn't mention the names of any of the other children who he alleges were put into the washing machine. However in his police statement he is more specific. He states both myself and NL 5 used to take care of the laundry. He said on two occasions he recalled the two of us placing him inside the machine and closing the door for 30 seconds.
- This did not happen. The laundry room was outside the main house. There was a lady who was in charge of the laundry room. I recall her name was door to the laundry room would be locked when she wasn't there. I did not have a key. I would have gone to the laundry room a few times every week, mainly to wash woollens would be there. On other occasions I would have left which were done by hand. in some clothes to be washed or occasionally I would have picked up some clothes after they had been washed and ironed. I do not recall any occasion in which I would have It is possible she would have gone to the laundry room, specifically with NL 5 been there when I came into the laundry on occasion but we worked with separate groups of children and I would only come across her occasionally, most commonly during the supervision of children at mealtimes. I don't recall HIA 19 I cannot say whether he was even in my group of children that I helped to supervise. I did work with different groups and I note he states he was placed in Our Lady's Group. While it is possible I was looking after his group for a period of time, I believe the reason I don't recall him is because I had only limited contact with him.

#### - HIA reference 21

32. I have read the statement of HIA 21 and to the HIA Inquiry which is dated 1<sup>st</sup> May 2014. I am unaware if he made a statement to the police but I was not interviewed by the police in connection with his allegations.

- 33. He alleges from the age of 6 until he left Nazareth Lodge in August 1968 he suffered systematic physical and psychological abuse from me and that I dominated his existence. I categorically deny all the allegations he has made against me. In fact I do not even recall him although it is possible that I worked in his group for a period of time.
- 34. I do not believe I worked in Nazareth Lodge for a substantial part of the time he alleges I was abusing him. According to his account he was systematically abused by me from around 1962 until 1968 but I have already stated that for a substantial part of this time I was living and working in England, Wales and in the USA. However I would accept there were periods during the time (HIA 21 was in Nazareth Lodge that I was working as a House Mother. I refer to the reference from SR 172 which is dated 26<sup>th</sup> August 1968. This describes my position as a House Mother for the past two years. This confirms my view that I was not working in Nazareth Lodge for most of the three or four years before this and so I could not have had any contact with HIA during those particular years.
- 35. In his statement he describes incidents in which he was brought to the middle of the dining room, in front of all the other children, and food was forced into his mouth. During this time he alleges I was kicking and punching him and he states all the children in the room would have witnessed this. This did not happen. If this activity had taken place in front of all the children, then I would have thought others would have come forward and described it when making statements to the police. I also deny the allegation made against me in paragraph 9 of his statement in which he alleges I pushed a young boy called NL 72 down the stairs. I vaguely remember NL 72 but I don't recall if he had learning difficulties. I also don't know if he was in my group of boys but I definitely never pushed any child down the stairs.
- 36. He has described a serious assault during the summer holidays in Ballyhornan and that his foot was bleeding and he required to go to a local hospital for treatment. However he does not appear to have complained to anybody about his allegations against me on this or any other occasion and in particular he never mentioned any of this to the nuns with whom he appeared to get on well. He describes another assault on the very day he was leaving Nazareth Lodge but I find it puzzling he would not have gone to one of the nuns at that stage since he was about to leave Nazareth Lodge. I deny his allegations.
- 37. He concludes his statement by describing meeting both me and NL 5 in later years. I have no recollection of meeting him in Andersonstown as he has alleged and I also note when he confronted NL 5 she said she was unaware that I was physically abusive to him or any of the other boys. I also note he claims this meeting took place in 1976 or 1977 but I was not even in Belfast during those years. I have already stated I went to South Africa in 1975 and I have exhibited to my statement a reference from Kiddies Kingdown Nursery School in Johannesburg which is stamped dated 11<sup>th</sup> August 1975. In fact I remained in South Africa until 1991 apart from a brief holiday in January 1980 when I returned to Belfast for a few weeks.

#### - HIA reference 104

38. HIA 104 made his statement to the HIA Inquiry on 25<sup>th</sup> February 2014. He stated he was born on 16<sup>th</sup> May 1963 and was admitted as an infant to Nazareth Lodge where he stayed until 29<sup>th</sup> August 1974 when he would have been 11 years old. He has described a single incident which he says occurred when he was between 8 and 10 years

old, between 1971 and 1973. He alleges that he was in the dormitory and NL 5 was making the bed and slapped him. He described me as her side kick and that I then came in and started to beat him as well.

39. I worked with a different group from NL 5 and it would be unusual for me to be working alongside or close to her in the morning time. I believe I was living and working in Manchester for most of the period between 1971 and 1973 but, I accept I was working in Nazareth Lodge when my mother died in 1974.

This is confirmed in the reference from which is dated 18<sup>th</sup> November 1975. I believe I obtained this reference before going to work in South Africa.

- November 2010 but he described it in a slightly different way. In his police account he alleged I was the person assaulting him in the dormitory when in the middle of this came into the room and told me something which resulted in me leaving the room in tears. He alleges he later found out that I had been told that my mother had died whereas in his statement to the HIA Inquiry, he claims I had been told it was my father who had died.
- 41. I do not recall HIA 104 I have no recollection of hitting him. I have a clear memory that it was SR 34 who told me that my mother had died. My mother died on 20<sup>th</sup> February 1974. My recollection is she died on a Tuesday night and I was told this first thing the following morning by SR 34 My brother had come up to Nazareth Lodge to tell me and as soon as I heard I went straight home with my brother.

I cannot think the nuns would have told NL 5 first of all and then asked her to tell me. I therefore believe the allegation made by HIA 104 could not possibly be true.

#### - HIA reference 110

made a statement to the police on 30<sup>th</sup> May 2012 and a statement to the HIA Inquiry which is dated 10<sup>th</sup> September 2013. I was interviewed by the police about his allegations on 19<sup>th</sup> October 2012 and I told the police I remembered a man called who used to be in Nazareth Lodge and that I met him years later when he was working in Milltown cemetery. While I cannot be certain, I believe he is the same who used to be in Nazareth Lodge and that I met him years later when he person and if it is, I am surprised by his allegations as he was always friendly and chatted to me when I met him in Milltown cemetery. I agree with some of the things he has said. I have already mentioned that I used to supervise the children sometimes on a Saturday when they were taken to the Curzon cinema on the Ormeau Road and I also agree that some of the other older children would have polished the floor and this would have happened usually in the morning before school when there was some free time after breakfast. This would normally only be for 15 or 20 minutes at a time. They stood with a cloth beneath their feet and moved it up and down. But I deny the allegations in paragraph 9 of his statement. I did not strike any child across the face if they did not like the food. I believe if this happened it would have been witnessed by other members of staff who were in the dining room. I also recall during the 1960's dinners became subsidized by the state. I recall the school lunches were prepared and brought into the dining room and I believe there were two ladies employed by the Education Board to serve these lunches to the children. They would therefore have observed what was going on in the dining room and would have seen any such assaults as alleged. I recall one of


the dinner ladies was called . While I agree ML 3 may also been supervising lunches with me I do not accept any of the children were assaulthis way.	
43. I deny that I ever placed HIA 110 or any other child into the washing machine in the laundry room and threatened to turn it on. I have already said I dhave a key to the laundry room and could only access it when there. I also deny I slapped him in the face as he has alleged.	

### - HIA reference 183

44. I do not recall this person but I have noted in his HIA statement he was in Nazareth Lodge Children's Home from 1<sup>st</sup> September 1951 until 12<sup>th</sup> August 1957. I believe I would only have been working in Nazareth Lodge for six months during this time which was the early part of 1956 and I then went to the convent in Hammersmith, London in July 1956. During the six months I was there, I recall I worked with the toddler's group and HIA 183 would then have been 10 or 11 years of age and so I would not have supervised him. I deny I struck him or any child in the face for no particular reason as he alleges. I am satisfied his allegations against me are false and there was no reason for him to claim I was not suitable for that job because of what he claims was my vile temper.

#### - HIA reference 225

- has made a statement to the HIA Inquiry which is dated 10<sup>th</sup> March 2014. In it he says he was in Nazareth Lodge between 1965 and 1968. As his date of birth is 25<sup>th</sup> September 1956, it would appear he was placed there when he was 9 years old. I do not recall HIA 225. He has claimed he observed me shoving a flannel into the mouth of another boy called who wet the bed and that I beat him in front of everyone in the dormitory. I deny this completely. I do remember Sometimes I would have taken him or some other child out of the Home and brought him by bus to my mother's house for the day and then I would have brought him back with me that evening. It was like a day out. I recall was one of the children and I took him to my parent's house a few times. I was quite fond of the child. There is no way I would have pushed a flannel into his mouth as alleged.
- 46. He also claims I punched him and that he told his father who then attacked me and knocked me over. This did not happen. I do not recall his father or if he got a job painting around the Home. He alleges I attacked a number of boys when on holidays at Ballyhornan during the summer. He alleges I hit the boys with a small wooden bat. I deny this completely. I never used a wooden bat to hit anybody. I did sometimes use a



I cannot recall if HIA 225 was one of them. I also do not remember if the four boys were given toys afterwards but if they

were I do not accept I would have taken the toys away afterwards.

47. In addition to the HIA participants, I have been provided with details of other allegations made against me.

NL 8

- 48. She made a statement to the police on 19<sup>th</sup> July 1995 in which she stated she was born on 20<sup>th</sup> February 1964 and her maiden name was NL 8. She stated she was 7 years old when she returned to Nazareth Lodge and remained there for about 3 years i.e. from around 1971 until 1974. I worked in Nazareth Lodge for only part of the time she was a resident. The police investigation report refers to an initial interview of NL 8 on 23<sup>rd</sup> January 1995. At that time she did not make any allegation against me although she did describe a minor incident involving another member of staff which allegedly occurred in the girl's toilets. The fact that she did give some information to the police but did not make any allegations against me at that time is surprising and the police have commented that this undermines her credibility.
- 49. In her second statement she describes in detail a particular incident involving both her and another child, The police then approached HIA 48 seeking to corroborate her account.
- 50. However when she made her statement recollection of me assaulting the two girls as described by NI. 8 Given the description of this incident by NI. 8 which included me locking the two girls in a shoe cupboard before beating them so hard that their bodies were covered in welt marks from the cane, I believe HIA 48 would have recalled this incident if it had in fact occurred. The fact is however NI. 8 ris has described this incident in an exaggerated manner to portray me as a cruel and vicious person. My immediate response to her allegations when put to me by the police was that they were simply untrue and they did not happen.
- 51. I also told the police I had some difficulty recalling NL 8 although during my initial interview I said I had a vague recollection of her. After the police interview I reflected on what they had said and after a period of time I did in fact recall some detail about this incident but not in the way described by NL 8 . I mentioned this to the police when I was interviewed by them a second time and I will refer to it later.

- 52. The police also told me in the bathroom and that I left her suspended her and hung her up on a hook on the wall in the bathroom and that I left her suspended there for at least 20 minutes or possibly an hour. I then returned, lifted her down and put her into a bath full of cold water and pushed her head under the water until she started to choke. She thought she may have passed out in the bath. None of this happened. Usually there would be a number of people present when the children were being bathed. There were two sides to each bathroom and there would have been other staff members present bathing other children at the same time. It is also ridiculous that I could have left a girl hanging on a clothes hook and simply walked away without anyone noticing.
- She described me attempting to choke her by putting my hand over her mouth in the dormitory because of bedwetting, threatening to kill her and also forcing her to stand in a cupboard all night because she had wet the bed the previous night. Again these allegations are all lies. I have already stated a nun slept in a cubicle at the side of the dormitory and it is impossible the nun would not have been aware of this happening. She alleges that sometimes after beatings her body would have been marked and bruised. She alleges I used a hand brush to beat her with. Again I believe it is impossible other staff members or nuns would have failed to notice this, particularly if she or indeed or any child had marks on her body. She also told the police in her statement that I forced her to lie on the floor in the dining room and put porridge into her mouth and if she spat it out I made her put it in again. She claims after being forced fed the porridge she had to go and get her daily dose of treacle which everyone had to get. I deny this completely. If this is supposed to have happened at breakfast time then there would have been other adults present including usually a nun. I also believe she is confusing treacle with a syrup known as virol or malt which the children did get most days. In fact my mother used to give it to me when I was a child. Some adults took it. It was supplied by the nuns.
- 54. She also alleged that I was forced to leave the Home by the Mother Superior because a complaint had been made against me. Again this is not true. I did leave the Home on a number of occasions because I was going to work elsewhere. I was never warned by the nuns about my behaviour towards the children and I have enclosed references from the nuns at Nazareth House regarding my work there. I do not believe the nuns would have given me good references if they thought I was abusing children. I deny trying to force feed NL 8 or any other child as she alleged. I note her brother DI. 131 also made a statement to the police on 6<sup>th</sup> March 1995 and it was only after he made his statement that a second statement which included all of these serious allegations against me. Her brother's statement is very vague and he in fact states he can't remember the exact incidents because it was so long ago. I deny I beat him or dragged him along by the hair as he has claimed.
- who made his police statement on 14<sup>th</sup> June 1995. He alleges I punched him for misbehaving or for wetting the bed and that I would pinch him on the arm. I told the police I remembered NL 272 who came to Nazareth Lodge when he was about 10 years old and stayed for a year. I deny beating him or any other child for wetting the bed. If I did wake up some of the children to bring them to the toilet at night, there would have been a nun sleeping close by and so it would have almost impossible for me to strike any child without being observed.

- 56. The police informed me of allegations made in a statement from NL 95 taken on 17<sup>th</sup> August 1995. In his statement he says he was placed in care for a period of about six months at Nazareth Lodge Children's Home, Belfast when he was about 10 years of age. This would have been around 1969. He alleges I beat him with a stick on at least two occasions. He says he was beaten around the arms and legs but never injured, although he may have received bruising.
- 57. I deny his allegations. I am sure the nuns or other staff members would have asked questions if there was bruising on any child. I also do not recall this individual and I am not sure I was even working there for the full six months he was placed in the Home.
- 58. Although he describes being beaten by a stick, I would say that on occasion I used a ruler to hit children who were misbehaving. I would have used the ruler mainly on their hands and legs. I deny using a cane or any other implement to punish children.
- 59. The police interviewed me again on 19<sup>th</sup> October 2012. They referred to a statement made by HIA 48 on 8<sup>th</sup> December 2010. This was her second statement to the police. In her first statement which was taken on 24<sup>th</sup> July 1995 she said she recalled me giving her the odd slap on the ear for wrong doing but she had no recollection of any serious beating carried out on both her and her friend NL 8
- 60. However in her second statement to the police she made more serious allegations against me. She alleged I rubbed her face into the mattress if she wet the bed and that I told her and NL 8 to strip down to our pants and I would then beat them. She alleged that I locked both girls in a room and sometimes put them into a bath full of either cold water or hot water. She also alleged that after the two girls had run away and were brought back by the police they were beaten again. She claimed when any of the children had bruises they would not get out at the weekend and families were told they were sick. She described me as an evil woman.
- 61. I do not understand how she could make these allegations, particularly after she made no such claims when the police specifically spoke to her in July 1995 about similar allegations made by NL 8 . On that occasion HIA 48 signed a statement in which she said she had no recollection of me giving the two girls a severe beating with a cane after they had run away from the Home.
- 63. I thought it was appropriate to slap them because they had run away but that was the end of the matter and I certainly did not beat both girls until they were bleeding. I also informed the police that there was a small room in which shoes were stored. It was not a cupboard. I believe it is quite possible I told HIA 48 and NL28 to tidy up the shoes and put them together but the door was left open. It was not locked. They were not kept in there as a punishment. I believe they have exaggerated this to give the impression I was being cruel to them which was not the case.

### OFFICIAL-SENSITIVE-PERSONAL

- 64. The police also referred me to a statement from the said he remembered DL 131 being hit by me with a brush or mop shaft. I deny this and if I used a large object like this on a boy, I believe he would have remembered it.

  DL 131 himself does not describe me hitting him with a brush or mop shaft.
- 65. I worked with young children in South Africa between 1975 and 1991 when I returned to Belfast. I have had no further periods of employment at Nazareth Lodge. I completed a pre-school foundation course in June 1992 and also obtained employment in a day care scheme in Belfast. I refer to the documentation attached to this statement.
- 66. I generally have happy memories of my time working with children in Nazareth Lodge. The conditions were far from ideal, resources were limited and I had to work long hours for little remuneration but I saw it more as a vocation than simple employment. As I said to one of the former residents whom I met, they were hard times for everyone and in particular the children. I am disappointed that a number of former residents have made these allegations against me but I do not believe I used excessive force or was unnecessarily cruel to the children that I helped to supervise.

1. I refer to my previous statement which is dated 11th January 2015. I have now been asked to comment on the statements of five further applicants to the Inquiry who have made allegations against me.

### 2. — HIA refeerece 422.

I have no recollection of this person and cannot say whether he was in a group of boys that I supervised. In his statement at paragraph 14, he makes a general observation that I was wicked and a bully. He gave as an example if I caught him out of bed. I have already explained that once the boys went to bed I had no contact with them, apart from one late evening check at around 9pm. I would have taken it in turns with a nun to waken up those boys who were known to frequently bed wet. They would have been taken out to the toilets and then returned to bed. I had no other supervisory role after this.

- 3. He also claims that I told him to brush the floor in the dinner hall at Ballyhornan. I have no recollection of this. The dining room was off the kitchen and it would normally be the kitchen staff who would sweep up the floor.
- 4. He states I asked him for money to get my hair done. This is not true. I never went to a hairdresser during those years. It was usually one of my sisters who fixed my hair or gave me a perm. I don't think I would have had much or any contact with this particular child unless he was in my group.

### 5. <u>– HIA reference 56.</u>

I recall HIA 56 My memory is that he was a nice child and that his mother would have visited nim regularly in the Home. She may have been a shop assistant. She could have called to see him most weeks. He says he was in Our Lady's Group and for a period of time I did help a nun supervise this group.

6. In paragraph 9 of his statement he describes NL 5 and myself patrolling the dormitories to check if the children were asleep. This was not the case. I have already stated I only supervised those children in my group and I had no reason to go into any other dormitories and I did not work alongside NL 5 I only checked children who were known to bed wet and this would have been around 9pm. After this I had no further contact with the children until the following morning and the nun in charge would have dealt with any problems which arose during the night.

7. He also alleges that he saw me hit people with my hand. I did slap children with
my open hand on their leg, hands and occasionally on their bottom. This was a form of
chastisement. I was not overly physical with any child. His claims about
not true. The only child I remember defecating in his bed at night was
and I have referred to this in my previous statement. I do not recal NL 174
but I am sure I never rubbed any child's face in their own mess.
8. HIA 56 is another former resident who has described me as returning to
the Home dressed as a nun. I am very curious about this as I am clear I never worked
with any children dressed as a nun.

- 9. He also alleges that on one occasion I called his mother a tart and that I punched him on the shoulder. Again I deny this. I was not told the family circumstances of any child who was in the Home.
- 10. I have been informed that when HIA 56 gave evidence to the Inquiry on Thursday 15<sup>th</sup> January 2015 he claimed some of the nuns and a fellow lay member of staff called NL 5 were scared of me. This is not true. I got on well with my fellow workers and the nuns and was always able to return to work in Nazareth Lodge after being away for a while. I was also able to ask the nuns for references when I went to work elsewhere. I have been told HIA 56 alleged I kept dogs in kennels at Nazareth Lodge. I have no idea where he got this information from. While it is possible there was a dog kept at Nazareth Lodge at one time I never had anything to do with it. In fact I have never owned a dog and I am nervous of dogs generally.

# 11. - HIA reference 36.

I have been made aware HIA 36 made a statement to the Inquiry in which he stated he was admitted to St. Joseph's baby home in 1957 and to Nazareth Lodge in 1961 where he remained until 20<sup>th</sup> August 1968. In his statement he said most of the staff in Nazareth Lodge were really good people and were good to him. However he describes abuse carried out by certain individuals and from some older boys in Nazareth Lodge. He did not mention or make any reference to me in his statement to the Inquiry and so my solicitor was not notified and did not attend when he gave evidence. However I have been informed that when he spoke to Counsel to the Inquiry before giving evidence, he referred to me and said on one occasion after returning from holiday I pulled him into the dining room and beat him. He then went on to allege he saw me beating other children and he described me as having zero tolerance of children. He further alleged that I was frequently called to deal with children if they stepped out of line. In response to a question from a member of the panel he alleged that I hit him quite a few times.

I am shocked by his allegations. I cannot understand why he would not have made any mention of me in his HIA statement if his evidence to the Inquiry is to be believed.

I do not believe he was in the group of boys that I looked after and so I would not have had much contact with him during his stay in Nazareth Lodge.

I remember at some stage, probably during the 1990s himself to me and this is why I now am able to recall him. I believe he owned a shop compared me. He told me his name and he talked to me for a while. He was very friendly. I therefore find it most surprising that he now is making these totally untrue allegations about me. I do note he said in his statement to the HIA Inquiry that he has kept in contact with some of the ex-residents from Nazareth Lodge and that they have reunions on occasion. I can only wonder if he was given my name by some of the other residents and then for some reason he has decided, at the last moment, to make up these allegations against me.

### 12. – HIA reference 147.

I have been informed James Lee gave evidence to the Inquiry on Thursday 15th January 2015. The first thing I want to say is that I do not recall him and I understand he has said he was in the group in which NL 5 was the main lay worker. However he has alleged that he was beaten on a number of occasions by both NL 5 and myself. He has not described any of the incidents in detail and I understand he has not previously mentioned or referred to me until he made a short statement to the Inquiry which is dated 9th January 2015. Counsel to the Inquiry stated HIA 147 had made two statements to the police and provided a number of medical reports which described the abuse which he alleges occurred. My understanding is that I am not mentioned in any of those earlier documents and this is why I was not asked to comment on his allegations before now.

As I do not recall. HIA 147 and believe he was not in my group, I have nothing really to say other than I deny I would have beaten him or used a PVC type of bat and a stick as he now alleges.

# 13. – HIA reference 152.

I am aware HIA 152 has made a statement to the HIA Inquiry in which he states he was in Nazareth Lodge between 1958 and 1966. He said he was placed in Our Lady's group and that SR 47 was in charge of the group and she was helped by a lay worker who was myself. He alleged that another lay worker and myself used to go round the dormitories at night time and if the boys were not sleeping they would be taken out to the big washroom. I have already stated it was my practice to carry out a dormitory check on occasion at around 9pm and I would have taken boys who were known to bed wet out to the toilets. This may be his recollection. He has made no specific allegation against me and yet in his statement he has described the lay workers as evil.

also made a statement to the police on 20<sup>th</sup> August 2011 in which he alleges physical assaults at the hands of the nuns and lay women, but again he does not go into any detail or make any specific allegation against me. I recall being interviewed by the police about his allegations on 19<sup>th</sup> October 2012. I informed the police I did not remember HIA 152 although I did agree I did work with RA 47 and help oversee the Our Lady's group. It is therefore quite possible RA 47 was supervised by me for part of the time he was in Nazareth Lodge.

I also agreed with the police that if a child was brought from the dormitory to the toilet and he did not need to use it, I would have waited some time in order that the child might

go to the toilet. My recollection is that I would only have kept a child waiting for a few minutes before taking them back to the dormitory.

- 1. I refer to my previous statements dated 11th January 2015 and 20th January 2015.
- 2. I have stated my employment at Nazareth Lodge between 1956 and 1975 was irregular and that I spent lengthy periods of time living and working in England, Wales and the United States of America. I have now been able to obtain a copy of my General Practitioner's medical file and I attach the following edited extracts in support of this:-

### - HIA REF:

- I have been provided with a copy of this person's statement to the HIA Inquiry which is dated 27<sup>th</sup> November 2014. I have previously commented on the two statements made by HIA48 to the police but I was surprised to read she is now making further new allegations against me. My comments on these are as follows.
- It is quite possible I worked with a nun supervising the Scared Heart Group during part of the time HIA48 was in this group but as I have previously stated, I spent a considerable part of the 1970's working and living outside Belfast.

- 6. I deny all the allegations she has made in paragraph 6 of her statement and I never put Jeyes Fluid into bath water. I do recall from time to time children would have been given toys as gifts when they went to Christmas parties outside the home and it is also true the toys would have been taken from the children and not left in the dormitories. However the toys would have been left in another room and the children could have played with them at certain times. I do not recall being in the home at Christmas time as I usually spent this with my own family. However I would say that the staff and the nuns ate food prepared from the same kitchen as the children and I also recall everybody ate the same food at the holiday home in Ballyhornan during the summer.
- 7. In paragraph 13 she claims there were no inspections and doctors and dentists did not visit the Home. My recollection is that whenever a child needed medical treatment, they would have been taken out to see the doctor.
- 8. I cannot recall what visitors came to see HIA48 during her time in Nazareth Lodge. My recollection is that usually visitors came to take the child out for the afternoon or at weekends but it is also possible visitors would see the child in the parlour of the home. I would not be present and I did not supervise visits as she has alleged.
- 9. In paragraph 17 of her statement she makes an allegation which I was not previously aware of. What I can say is I was never told or heard anything about an allegation she was sexually abused by a man outside the Home. If this did happen, and the police were informed, then I do not believe the nuns would have told me about it. I certainly would have no reason to become involved or attempt to influence what she told the police or a court. The police never mentioned this allegation to me when I was interviewed by them at Musgrave Street Police Station on 19<sup>th</sup> October 2012. If she is now saying this is what happened to her during her time in Nazareth I wonder why she did not mention it on either of the two occasions she made statements to the police.

#### - HIA REFERENCE DL269

10. In his statement he has stated he was in Nazareth Lodge from approximately 1959 to 1965 and he makes a specific allegation against unnamed domestic workers that he was repeatedly beaten with a solid plastic racket. I have no recollection of seeing any such racket in the Home while I was there and I certainly did not use one to beat children with. I remember the name of DLA269 but have no personal recollection of him and I deny using excessive force on him at any time.

7	If you wanted to go to a foster home, you were given
8	that option. You were encouraged, of course, but you
9	didn't have to go if you didn't want to.
