

**Historical Institutional Abuse Inquiry**  
**Press Release by the Chairman – Sir Anthony Hart**  
**1 November 2012**

Sir Anthony Hart, Chairman of the Historical Institutional Abuse Inquiry released statistics today showing the number of applications received since the launch of the Inquiry helpline and website on the 1<sup>st</sup> October 2012. During the first month, a total of 101 returned applications were received of which 71 came from Northern Ireland, 7 from the Republic of Ireland, 19 from Great Britain and one from Europe. 3 forms were returned which were incomplete. The majority of applicants (72%) have indicated a preference to meet with both Acknowledgment Forum and the Statutory Inquiry. 22% did not indicate whether they wished to meet either the Acknowledgement Forum, Statutory Inquiry or both.

The Chairman in releasing the statistics said **“we are encouraged with the initial response to a low key Inquiry launch, which was to ensure that the Inquiry team could return all questions raised by phone within two days and to resolve any identified early problems.**

**“A number of applications have been received which have included no name or address or where the writing is illegible or all sections not completed. All applicants are encouraged to ensure their forms are fully and clearly completed. If an applicant has not received an acknowledgement letter within two weeks of posting they should contact the help desk on Freephone 0800 6884935. If phoning from outside the United Kingdom, the country code 0044 should be added. Applications are available upon request from the help desk or can be downloaded from the Historical Institutional Abuse Inquiry website at [www.hiainquiry.org](http://www.hiainquiry.org)**

In conclusion the Chairman said **“statistics relating to completed applications will be updated on the website on a regular basis”.**

1. Following an inter-departmental task force report, the Northern Ireland Executive, on 29<sup>th</sup> September 2011, announced there would be an Investigation and Inquiry into historical institutional abuse.
2. On 31st May 2012, the First Minister and deputy First Minister announced the Terms of Reference for the Inquiry and advised the Assembly of the Chair of the Inquiry and the panel members for the Acknowledgement Forum.
